Strongly disagree

Why?

Strongly disagree

Why?

This objective contain two contradictory statements. Th minerals and petroleum sector, if taken as an inclusive sector, cannot support a sustainable economy because the use of petrleum is not sustainable. If the petroleum industry supports New Zealand's transition to a carbon neutral economy, it will not be sustainable, given that

the scientific evidence shows that we cannot continue to use fossil fuels and avoid catastrophic global warming.

Objective for a sector that: "Is productive and innovative".

Strongly disagree

Why?

If the words productive are used for the ,minerals and petroleum,industry, there is an implication that there will be a continued use of fossil fuels and that cannot happen if we are to avoid the climate and ecological crisis that is rapidly becoming apparent

Objective for a sector that: "Is effectively regulated".

Strongly disagree

Why?

I believe in effective regulation of every industry but again, taking about effective regulation of an industry that cannot be sustainable is pointless.

cLosing down the petroleum element of the industry andseparating out the elements of minerals and fossil fuels so that minerals can be sustainably managed in a way that benefits New zealand and the rest of the world.

Guiding principles

Principle: The environment, ecosystems, and biodiversity are respected now and in the long term.

Strongly disagree

Why?

strongly believe that the environment, ecosystems, and biodiversity should be protected in the long term but they are not respected now. There is a lot of evidence of this in the degradation of fresh water, the many species that are endangered and the loss of forest and wetland in New Zealand. Once again, two statements that are very different have been linked together in a way that makes this point very difficult to discuss.

Principle: Māori cultural interests are understood and respected.

Neither agree nor disagree

Why?

I would leave this question to Maori to answer. My belief as a pakeha is that Maori have not been understood or respected historically and I don't believe that prejudeice has been overcome.

Principle: Support the transition to a carbon neutral economy by 2050.

Strongly disagree

Why?

I believe we need to be carbon neutral by 2030 at the latest.

Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Strongly disagree

Why?

People in certain areas, for example the West Coast have not been treated in a just and inclusive way over the extraction of coal, and in society as a whole, there are many ways in which a big industry such as the minerals and petroleum industry, does not treat people in a just and inclusive way, for example through pay and environmental management.

Principle: Support a circular economy by meeting resource needs through resource efficiency, recycling and reuse.

Strongly agree

Why?

This is the only way in which we can continue to provide for everyone in the future. It is essential to move from a wasteful consumerist society to one in which presious resources are valued and re-used.

Principle: Actions taken within the mineral and petroleum sector should align with the strategic direction of other related sectors and Covernment strategies.

Strongly disagree

Why?

The Government has not yet aligned itself with a strategy that will deliver carbon neutrality in the time frame that is needed to avoid catastrophic global warming. Therefore, many strategies are not yet going to be effective for the future.

Neither agree nor disagree

Why?

Principle: The Crown regulates in a way that is fair, transparent, reasonable and proportionate.

Strongly disagree

Why?

The 'Crown' consists of individuals with biases and prejudices at best and with vested interests at worst, making it almost impossible for the 'Crown' as an entity to be impartial.

Principle: The Crown honours the rights of current permit holders to continue production or exploration activities under existing permits.

Strongly disagree

Why?

Some of the existing permit holders hold permits for oil and gas exploration and I believe that these should be cancelled immediately. Worldwide, we cannot afford to use all the fossil fuels we already know about if we are to remain under 2 degress of global warming so it is totally irresponsible to search for more.

Principle: The Crown makes policy decisions based on the best evidence, and accounting for the foreseeable need for minerals and petroleum, both now and for future generations.

Strongly disagree

Why?

Once again, it is almost impossible for the individuals responsible for making decisions on behalf of the 'Crown' not of be influenced by industry interests or political opinions on how the economy needs to be managed.

Principle: The Crown proactively engages and consults with relevant stakeholders and decisions are communicated in a clear and transparent way.

Strongly disagree

Why?

All the ditizens of New zealand are stakeholders in the future of our environment and the Crown does not communicate truthfully about the climate crisis. Therefore, decisions are not made in a transparent way.
