Te Tiriti o Waitangi obligations under Article Two. Again this should be stronger in relation to tino rangatiratanga. M`aori perspectives need to be at the heart of the nation, and their voices central to all decision-making.

Principle: Support the transition to a carbon neutral economy by 2050.

Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Social harmony is important, as are Tiriti o Waitangi obligations.

Principle: Support a circular economy by meeting resource needs through resource efficiency, recycling and reuse.

Why?

The pursuit of ongoing economic growth at the expense of planetary wellbeing can no longer be condones as our over-arching narrative. We need to urgently reframe this in order to avoid climate catastrophe.

Principle: The Crown makes policy decisions based on the best evidence, and accounting for the foreseeable need for minerals and petroleum, both now and for future generations.

Why?

The Crown must exercise leadership in moving the nation away from fossil fuel dependence.

Principle: The Crown proactively engages and consults with relevant stakeholders and decisions are communicated in a clear and transparent way.

Why?

The climate emergency message needs to be communicated clearly and urgently so that stakeholders can begin to adjust their expectations and find alternative non carbon generating solutions.
