Action: AJ and Robert to meet with Minister Twyford

Intro commentary from Nigel Bickle.

Min Jones – notes a commercial holding company will be established – will affect 1BT, Kiwirail and include some roading [but it's protracted]

Min Davis – notes tourism focus on regional dispersal, access including in the East Coast region. Notes the importance of amenities that tourists use – the TIF won't cover it all, and neither will the visitor levy (though that will help). Expects focus on facilities and roads. *Nigel responds to this.*

Min Davis – references aviation report, and product development [for tourism].

Min O'Connor – questions around what the holding company will look like in 5 years time – a SOE? A company? *Discussion that Crown Irrigation Investments Ltd will not be used.*

Interested in why the Minister of Transport is a RED Minister, but the Minister of Technology [Hon Woods] is not. *Discussion that she should be linked in and strategies should be aligned.*

Will there be a right of review for parties whose applications are declined by the PGF/PDU? *Nigel responds.*

Hamilton and Tauranga – why aren't they excluded?

Use of **Commercial Information** example by Min Jones.

Min Jackson – notes there are 80k NEETs, and the HPR strategy needs to link in better with the PGF. There are good results so far, so what more can be done on this.

Min Mahuta's rep – notes she agrees with the direction of the Cabinet paper and is interested in geographic areas.
