Northland Drought	A severe drought has hit parts of Northland, with water levels so I that some town water supplies could run completely dry. Emerger preparations are underway in Kaikohe, which has been sever impacted by record dry conditions in 2019 and the start of 2020. C Defence Emergency Management has helped the Far North Dist Council install three large water tanks at the Returned Service Association building to supply residents and businesses if the tow supply runs out. Without substantial rainfall over the coming week Kaikohe faces the very real prospect of running out of water. Pl Officials are assisting the coordination of a government response the situation.		
Coronavirus impact in Northland	Northland businesses exporting to China are braced for the impact of the coronavirus outbreak. Restrictions imposed on travel and public gatherings in China in an attempt to contain the outbreak are putting the squeeze on New Zealand firms doing business there. Forestry crews across the country have downed tools as contractors close operations due to the virus. This has also affected transport companies whose trucks remain idle as a result of the shutdowns. PDU Officials are working with funding recipients to monitor the impact on their current projects.

#### 7. Policy Updates

#### 7.1 Policy

#### **Upper North Island Supply Chain work programme to May 2020**

Ministry of Transport Deputy Chief Executive Nick Brown presented to Auckland Council's Planning Committee this week, supported by The Treasury and independent consultancy Sapere. Mr Brown emphasised the scope and timeline that Cabinet has given Officials for this project, noting that the Ports of Auckland is not viable as the key import port in the long term, and that a report back to Cabinet is required by late May.

Key points raised by councillors included:

- Support for the evidence-based approach being taken
- Concern about the timeframe, particularly given the time it will take Auckland Council to agree a formal Council view, and how it might impact on engagement with iwi
- While being aware of Cabinet's position, a desire for the analysis to consider the status quo option, and potentially a "hybrid" status quo involving a functional port at the current site but with a reduced capacity and footprint
- A keenness to hear directly from Ministers on the issue
- Questions and concerns about how increased freight movements in and out of Auckland might impact on passenger transport, and on specific parts of the transport network (for example, the implications of needing to expand the Waitakere Tunnel).

Committee Chair Chris Darby emphasised that the views expressed at the meeting could not be taken as a formal Council position. He will discuss with his officials how a formal position might be developed.
