Updates

Maori Battalion Museum - Waitangi

MBIE has contracted with Waitangi Ltd to undertake stage one planning of the Museum, and to assist with preparing a business case for stage two investment. Waitangi Ltd is supportive of the two stage approach to fully inform the Trust of options, costs and business models.

Officials will be meeting with Greg McManus, CEO of Waitangi Ltd and project manager Privacy of natural persons on 22 February to scope the required information to advise the business case.

Waitangi Ltd will procure an independent consultant to undertake stage one planning. The business case is anticipated to be completed by April 2018.

Kawerau Container Terminal – Report Findings

The Kawerau Container Terminal opportunity was added to the Toi Moana Bay of Plenty Action Plan in 2016. SCION has completed the updated research and freight logistics modelling to include the Fenglin particle board plant which was announced mid-2017. This research will help Industrial Symbiosis Kawerau (ISK) to determine the viability of the Container Terminal. The updated report will be released shortly, the key findings include:

- 78% of containers would be better off on rail under all the scenarios travelling to the Port of Tauranga.
- A service to Auckland is not currently viable under this modelling; however, could be an option should the
 demand increase in future. The extension project modelled the Auckland service via the Horitiu development
 (Northgate). A Port of Tauranga service is preferable from an economic and environmental perspective.

- The economic impact for the Most Likely Case would equate to an approximate saving of \$\sime\text{commercian}\$ million per year (previously estimated at \$\sime\text{commercian}\$ m per year) plus environmental and social benefits. The savings would likely be redirected to growing their businesses and increasing incomes and jobs.
- The social impact for the Most Likely Case would reduce approximately 70,000 return heavy vehicles movements annually (approximately 200 trucks a day) from SH2 improving road safety for a busy tourist route and eliminate more than 8 million kilometres of heavy vehicle travel thereby, reducing highway maintenance costs. The previous estimate was 35,000 heavy vehicles movements annually (more than eighty trucks a day).
- The environmental impact for the Most Likely Case would reduce CO² emissions by as much as 25,000 tons per annum. The previous estimate was five to six thousand tons per annum.
- The research suggests that the container terminal as a business in itself generates viable returns. However, the capital costs to develop the infrastructure need to be considered in addition to these results.
- ISK are investigating options for establishing a business to operate the container terminal and securing the expected \$\circ{\container}{\circ}\$ million for the phased establishment costs.

MBIE contributed \$27,750 to the \$commercial Inform research project.

Following the presentation to Minister Jones in December, the Bay of Connections and Central Government are working with ISK to progress the six actions they need help with. To recap, ISK are seeking support for the following:
