On 14 April 2021, the Cabinet Economic Development Committee (DEV):

- 1        **noted** that on 4 December 2019, DEV:
  - 1.1        approved the Construction Sector Transformation Plan (the Transformation Plan) and endorsed its implementation by government agencies and industry;
  - 1.2        invited the Minister for Building and Construction to report back to DEV on progress on the delivery of the Transformation Plan by the end of 2020;
