Major Events Management (Rugby World Cup 2021) Order Revocation Order 2021

Portfolio **Economic and Regional Development**

On 6 May 2021, the Cabinet Legislation Committee:

- 1 **noted** that the Rugby World Cup 2021 was declared a Major Event with associated Major Event emblems and words and provided protections under the Major Events Management Act 2007 (the Act), through the Major Events Management (Rugby World Cup 2021) Order 2020 (the Order);
- 2 **noted** the Order will come into force on 18 May 2021;
- 3 **noted** that on 8 March 2021, the Rugby World Cup was postponed until 2022;
- 4 **noted** that the:
 - 4.1 Minister for Economic and Regional Development recommends that the Major Order should be revoked;
 - 4.2 Major Events Management (Rugby World Cup 2021) Order Revocation Order 2021 (the Revocation Order) gives effect to the recommendation;
- 5 **noted** that the Act requires that, before recommending the making of an Order in Council, the Minister for Economic and Regional Development must consult with the Minister of Commerce and Consumer Affairs, the Minister for Sport and Recreation, and other persons;
- 6 **noted** the advice of the Minister for Economic and Regional Development that this consultation has been undertaken;
- 7 **noted** that:
 - 7.1 a waiver of the 28-day rule is sought so that the Revocation Order can come into force on 14 May 2021;
 - 7.2 on the grounds that revoking the Order 2020, and will have little or no impact on the public;
- 8 **agreed** to a waiver of the 28-day rule;

9 **authorised** the submission to the Executive Council of the Major Events Management (Rugby World Cup 2021) Order Revocation Order 2021 [PCO 23697/3.0].
