Accident Compensation (Maternal Birth Injury and Other Matters) Amendment Bill: Supplementary Order Paper

Portfolio ACC

On 28 July 2022, the Cabinet Legislation Committee:

- 1 **noted** that the Accident Compensation (Maternal Birth Injury and Other Matters) Bill (the Bill) holds a category two priority on the 2022 Legislation Programme (must be passed in the year);
- 2 **noted** that in May 2022, the Cabinet Social Wellbeing Committee agreed to amend the Bill through a Supplementary Order Paper, to implement the Budget 2022 bid “Align the timing of increases to the minimum and Loss of Potential Earnings rates of weekly compensation with increases to the minimum wage” [SWC-22-MIN-0088];
- 3 **noted** that the Bill is currently scheduled to have its second reading on 27 July 2022;
- 4 **approved** the Supplementary Order Paper [PCO 22578-1/3.0] for release for the Committee of the Whole House stage of the Bill;
- 5 **noted** that the policy change in the Supplementary Order Paper will commence 30 days after the date on which the Bill receives Royal assent, which is aligned with most provisions in the Bill.
