## ANNUAL LETTER OF EXPECTATIONS FOR 2023/24

I write to convey my strategic and performance expectations for GNS Science in relation to the 2023/24 financial year and beyond, on behalf of shareholding Ministers.

### Te Ara Paerangi - Future Pathways

Te Ara Paerangi Future Pathways is a multi-year programme focused on the future of Aotearoa New Zealand's research system. The programme involves an open and wide-ranging conversation on the issues facing the research system, how these might be addressed, and how to take advantage of emerging opportunities within our sectors.

Thank you for the involvement from leadership, management, researchers and staff on the process so far, including for the range of submissions in response to the Green Paper. Your engagement is helping to progress the science system for Aotearoa New Zealand. I have appreciated that Boards have enabled staff to participate throughout this progress.

Through the consultation, we heard a strong desire for transformative change, and the White Paper marks the beginning of the transformative process to respond to the issues raised in consultation.

The White Paper sets out the vision for our future research, science and innovation system and includes key policy directions and actions we are pursuing. It also provides a roadmap to implementation and demonstrates how we will continue to work with the sector as the reform progresses.

Key policy directions for the research, science and innovation reform are set out over four objectives:

- **Creating New Futures** through new National Research Priorities and incentivising connections with the private sector to increase impact.
- **Valuing Our People** so we can attract, develop and retain an excellent and diverse workforce.
- **Building System Agility** so that our funding, institutional and governance structures support an adaptable, resilient and future-focused system.
- **Embedding Te Tiriti** across the design of the RSI system to address the current system's poor responsiveness to Māori.

Your work and input are vital to the reform, and we look forward to your ongoing contributions.

Aligned with the work currently underway on Te Ara Paerangi Future Pathways, it is expected that entities will:

- Incorporate a system-wide perspective in collective strategic planning, and meaningfully engage with key participants in the system.
- Implement a collective approach to capital planning, co-locating and resource sharing with relevant parties where this opportunity exists, to provide resilient investments across the Crown.
- Clearly articulate how you have considered co-location of research facilities in business cases for significant capital investments.
- Give effect to Te Tiriti O Waitangi obligations and expectations, and contribute towards the Tiriti Statement for the research, science and innovation system.
- Have a pan-CRI approach to the use and sharing of resources, services, capability, assets and people.
- Build strategic relationships with government, other research organisations, Māori, businesses, international organisations and other key stakeholders.
- Continue to maintain and invest in capability and infrastructure for the benefit of New Zealand where appropriate.

Please provide a pan-CRI report to me on progress towards the expectations relating to Te Ara Paerangi – Future Pathways by 28 April 2023, and it is my expectation that a pan-CRI report on progress is provided every six months thereafter.

### **Research, Science and Innovation Property Portfolio**

There is significant potential for research system performance improvements from co-location of research facilities with other CRIs and with Universities. We expect you to continue to work in good faith with my officials to achieve this outcome, and we expect any business cases you develop for significant capital investments to clearly articulate how you have considered co-location of research facilities. Shareholding Ministers' approval of business cases will in part be contingent on co-location being adequately considered.

The current work underway in relation to the Wellington Science City is an example of exploring the co-location opportunities of several CRIs and relevant stakeholders with the vision of creating science and research hubs within the capital. Thank you to those involved in the process, and we look forward to seeing how this work develops.

### **Board of Directors**

Boards have an important role in leading organisations through change. I look forward to working with you to ensure that your Board is well positioned to support your organisation through the Te Ara Paerangi – Future Pathways process.

I encourage CRIs to explore the option of appointing potential Future Directors to your Boards in a learning capacity, as a way to increase the diversity of perspectives and develop potential directors within the research, science and innovation system.

Ensuring the Board is, and remains, high performing is essential. I expect you to carry out an annual evaluation that is ideally conducted by an independent evaluator, and provide my officials with a summary of the results by the end of each calendar year, or at a later date by agreement with officials.

## **Financial Resilience and Sustainability**

It is expected that CRIs will continue to build long-term financial resilience and sustainability. Further, we expect you to work with MBIE to deliver your 10-year capital intentions and funding plans in 2023, as part of the financial resilience and sustainability work. We also expect you to continue to work with my officials on the development of, and your performance against, your key performance indicators.

## **Environmental Data**

Consistency and availability of environmental datasets remains an important aspect of our sector. I expect entities to continue to progress work in this area, applying the New Zealand Data and Information Management Principles where appropriate. This includes making the outputs of your research freely available wherever possible, in-line with MBIE's policy on Open Research.

## **Specific priorities for GNS Science**

During the 2023/24 financial year, in addition to my expectations above, I expect you will:

- Actively support and constructively engage with the work underway in relation to the Wellington Science City proposal for Wellington to ensure the full benefits of this initiative are realised. I also expect you to continue to progress work relating to the Wairākei site Phase One and the Wairākei Geothermal Energy Innovation Centre proposal (Phase Two), and engage with officials as appropriate.
- Continue to work with officials and relevant stakeholders on hazards monitoring and advisory services, and long-term sustainable funding for monitoring infrastructure, data sets and data models.
- Ensure GNS Science manages its financial performance and position over time, with a particular focus on growing its margins and working towards being able to self-fund your key strategic infrastructure, and continue to engage on your progress with my officials.
- Continue to engage with officials in relation to health and safety of servicing equipment on Whakaari / White Island, and update my officials on the legal proceedings as appropriate.

Hon Dr Megan Woods' 2022/23 Letter of Expectations outlined a range of expectations for entities within the research, science and innovation sector, including in relation to Government priorities, Te Ao Māori, workforce inclusion and use of technologies, as well as entity-specific priorities. It is expected Boards will continue to progress work towards these areas where appropriate.

Entities should continue to follow the advice outlined in the Minister of State Services and Minister of Finance's Letter of Enduring Expectations. Furthermore, I expect entities to inform my officials of emerging issues and how the Board is planning to respond, and follow the general and good governance expectations provided to Boards.

## **Response**

Your advice by 17 March 2023 on how you propose to respond to the expectations set out in this letter would be appreciated. I expect that you will keep my officials up to date on your progress towards meeting my expectations throughout the year, including when my priorities are not being progressed.

Thank you again for the hard work and contributions of the Board, management team and staff.
