# Draft Cabinet paper for consultation – Updating and reopening the Parent Category Resident Visa

### **Purpose**

To provide you with a draft Cabinet paper on proposed revisions to settings for the Parent Category Resident Visa (Parent Category), to be circulated for Ministerial consultation. This paper is accompanied by a briefing on options for preferential treatment of Green List residents and some implementation details.

#### Recommended action

The Ministry of Business, Innovation and Employment (MBIE) recommends that you:

#### The draft Cabinet paper

# MBIE has prepared a draft Cabinet paper containing your recommendations on updating and reopening the Parent Category Resident Visa

- 1. The attached draft Cabinet paper at Annex One proposes that:
  - a. the income threshold for sponsors is lowered as outlined in the table below:

Income threshold for sponsors	One sponsor	1.5x median wage
	Joint sponsors	<u>2x</u> median wage
Sponsoring more than one parent	Income threshold increases by  0.5x median wage per parent (up to six parents)	

- b. eligibility for joint sponsorship arrangements is extended to allow siblings to combine their income to meet the relevant threshold, rather than just partners
- c. the annual cap on the number of visas that can be issued to parents increase from 1,000 to 2,000 per annum
- d. selections of expressions of interest (EOIs) from the existing queue recommence in chronological order
- e. future EOIs are collected and selected from a ballot, and selections from the ballot begin after the existing queue is clear.

Officials have also provided advice on options for Green List sponsors and implementation of the ballot [briefing 2223-0459 refers]

 The Cabinet paper includes officials' recommended options for the Green List sponsors and implementation of the ballot. If your preferred options differ from these recommendations, then officials will amend the Cabinet paper to reflect those preferences ahead of the draft going to your Ministerial colleagues.

The Cabinet paper addresses other administrative issues to assist with implementing the Parent Category changes

- 3. The draft Cabinet paper seeks Cabinet agreement to grant the Minister of Immigration powers to lapse future Parent Category EOIs, and to determine any other matters regarding the manner and form of the ballot. Our view is that this will provide flexibility to make changes to the Parent Category to improve its operation in the future more easily and without the current constraints.
- 4. The draft Cabinet paper does not describe the details of the ballot; however, our initial thinking is to hold EOIs for up to two years in the ballot pool. EOIs would expire if not drawn at this point and applicants would need to reapply. This approach keeps EOIs current, while limiting reapplication frequency for applicants. Bringing EOIs online should also result in a reduced cost. Officials plan to include the customer-facing details in the final Cabinet paper, following further consultation with Immigration New Zealand.

#### Other matters

5. The 'Impacts' section of the draft Cabinet refers to estimated demand pressure of the Parent Category changes, rather than giving a figure on the financial impacts. Officials are working with the Ministry of Health and Ministry of Social Development to development an appropriate methodology to calculate the anticipated financial impacts of the Parent

- Category. We are planning to have these figures finalised and included in the final Cabinet paper.
- 6. The draft Cabinet paper gives a specific date of Monday 14 November for resuming selections of EOIs. This date depends on the Parent Category changes being approved by Cabinet on 19 September. Any delays to Cabinet decisions or the announcement will result in the resumption date of EOI selections being adjusted accordingly.

#### Consultation

- 7. MBIE officials consulted on the draft Cabinet paper with the Ministry of Social Development, Ministry of Housing and Urban Development, Ministry of Health, Treasury, Ministry for Ethnic Communities, Ministry for Pacific Peoples, Whaikaha (Ministry of Disabled People), Ministry for Women, Ministry of Foreign Affairs and Trade, and Immigration New Zealand.
- 8. Feedback provided by these agencies has been incorporated where appropriate into the draft Cabinet paper. The key points of feedback received include:
  - a. While the lower income thresholds reduce barriers to access the Parent Category for some, this is not true for all. The Ministry for Ethnic Communities, Whaikaha and Ministry for Pacific Peoples noted that there would continue to be systemic barriers to access for former refugees, people with disabilities, and Pacific peoples.
  - b. The Ministry for Ethnic Communities, Ministry for Pacific Peoples, Whaikaha, and Ministry of Foreign Affairs and Trade expressed support for allowing siblings to enter into joint sponsorship arrangements, as this is far more inclusive of different family arrangements.
  - c. Treasury asked whether supplementary welfare assistance and tax credits (for example, Working for Families or the Accommodation Supplement) would be considered towards the income threshold for sponsors. Officials will follow up on this and provide further advice and amend the final Cabinet paper, if necessary. Our initial view is that the purpose of that assistance and tax credits is to assist with the costs of children or housing, and so should not count towards the income threshold for the Parent Category; rather, only taxable income should be considered.

### Next steps

9. You have previously noted that you want to progress this work as soon as possible. To support this, officials propose the timeline in the table below, which supports presentation of these proposals to DEV on 14 September and Cabinet on 19 September. However, we note that you are travelling on the week of 14 September and cannot attend DEV – if you prefer to attend when the paper is considered, the next available DEV date is 21 September, followed by Cabinet on 26 September.
