Budget 2022 initiative submission letter – Maintaining reduced MIQ capacity in 2023/24

Purpose

This briefing provides you with a letter to the Minister of Finance submitting the budget initiative 'Maintaining reduced Managed Isolation and Quarantine capacity' for consideration as part of the Budget 2022 process. The initiative seeks an additional \$180.1m in funding for the Financial year 2023/24 to operate Managed Isolation and Quarantine services as per the Moderate Transition Approach agreed by Cabinet on 13 December [SWC-21-MIN-0215 and CAB-21-MIN-0525 refers].

Recommended action

The Ministry of Business, Innovation and Employment recommends that you:

a **Note** that on 22 October 2021 the Minister of Finance wrote to you confirming the COVID-19 response initiatives that are invited for submission through Budget 2022.

- b **Note** that on 13 December 2 021 Cabinet:
 - a approved funding to deliver a reduced MIQ network until the end of June 2023 [SWC-21-MIN-0215] and
 - b agreed to establish tagged contingencies to support the development of detailed business cases for a National Quarantine System to support the ongoing COVID-19 response and future pandemic preparedness [SWC-21-MIN-0214].

c **Note** that the MIQ network capacity at the end of June 2023, according to the Moderate Transition Approach agreed by Cabinet, will be 1,300 rooms with some of this capacity exceeding the planned capacity of those facilities earmarked for longer-term acquisition as part of the recent National Quarantine System Programme Business Case.

d **Note** that consequently there is an estimated \$180.1 million funding gap for 2023/24 between the contingency put aside to progress the outcomes of the National Quarantine System Programme Business Case and the planned network according to the current Moderate Transition Approach.

e **Note** that while there is significant uncertainty about the funding that will be needed to maintain MIQ in 2023/24 as a result of unknown demand and work to be undertaken on the National Quarantine System, we consider that signalling potential additional costs involved in maintaining MIQ capacity through the Budget 2022 process reflects best-practice transparency.

f **Note** that if funding is not provided through Budget 2022 for MIQ operating costs in 2023/24, an out of cycle budget bid will be required, as occurred in December 2020 and December 2021.

- g **Agree** to submit the initiative 'Maintaining reduced Managed Isolation and Quarantine capacity' seeking \$180.1 million for the financial year 2023/34 for consideration as part of the Budget 2022 process.

Background

- 1. On 22 October 2021 the Minister of Finance wrote to you inviting you to submit COVID-19 Response initiatives through the Budget 2022 process. This includes a number of MIQ initiatives.
- 2. On 13 December 2021, Cabinet agreed to fund MIQ in the short term at a reduced network capacity until the end of June 2023. Cabinet also agreed to a transition approach (the Moderate Transition Approach) to scale down the MIQ network [SWC-21-MIN-0215].
- 3. Cabinet also agreed to establish tagged contingencies associated with the potential development of a National Quarantine System [SWC-21-MIN-0214]. Subject to future Ministerial decisions, these tagged contingencies would fund a smaller network of quarantine facilities beyond July 2023.

Maintaining reduced MIQ capacity in 2023/24

- 4. Based on the Moderate Transition Approach agreed by Cabinet, there will be approximately seven MIQ facilities providing an operational capacity of 1,300 rooms at the end of June 2023. The operational tagged contingency agreed to by Cabinet provides funding for three facilities (two from the existing network) for the financial year 2023/24, with exact capacity to be confirmed.
- 5. Assuming no changes are made to the Moderate Transition Approach, this leaves a gap in funding for five facilities as of July 2023, reducing to three facilities by the end of 2023/24. The cost of this gap is \$180.1 million.

Uncertainty about the MIQ capacity needed beyond June 2023

- 6. The exact scale and timing of the reduction and the capacity needed beyond June 2023 is currently unknown. Depending on international and local developments, the scale of the MIQ network needed beyond June 2023 could be greater or less than that currently funded.
- 7. Given the level of uncertainty, one option is to seeking funding in 2022 outside the regular budget cycle. While this may yet be the approach Government decides to take, our preference is to signal the potential funding needs through the Budget 2022 process for transparency, given we anticipate there will be some costs associated with MIQ in 2023/24.
- 8. We are proposing to seek \$180.1 million in funding for 2023/24 through the Budget 2022 process. The initiative 'Maintaining reduced MIQ capacity' seeks funding to deliver managed isolation and managed quarantine arrangements at a reduced capacity and provides funding for:
 - a. contracts with some facilities and transportation providers
 - b. workforce costs (for MBIE), including workforce adjacent costs (i.e. IT)
 - c. Funding for MCA categories required for the fee's regime.
- 9. This funding request is consistent with the Moderate Transition Approach agreed by Cabinet but does not reflect any of the changes or adjustments which may be made to the MIQ network in coming months. We are due to provide you with an update on the trajectory of the Moderate Transition Approach in April next year, following the initial implementation of this decommissioning approach, and the first steps for the reopening of borders.

Next steps

- 10. If you agree to include this initiative in the Budget 2022 package, we recommend that you sign and send the letter 'MIQ Budget Initiative Submission Letter' attached in (Annex One) to the Minister of Finance.
- 11. Subject to your agreement, officials will submit the initiative through formal channels.
- 12. Treasury will assess Budget 2022 initiatives by the end of January 2022. This will be followed by Budget Ministers' consideration in February and March 2022. Final Cabinet decisions on Budget 2022 are expected in April 2022.
