He Kai Kei Aku Ringa: Māori-Crown Economic Growth Partnership 2023 Action Plan

Portfolio **Māori Development / Economic Development**

On 27 June 2023, the Cabinet Māori Crown Relations - Te Arawhiti Committee:

- 1 **noted** that the Minister for Economic Development and Minister for Māori Development (the Ministers) were invited to report back with a He Kai Kei Aku Ringa 2023 - Action Plan (Action Plan) in June 2023 [DEV-22-MIN-0315];
- 2 **noted** that the Ministers have made minor edits to the objectives of He Kai Kei Aku Ringa 2023;
- 3 **noted** that the Ministers have made minor edits to the governance of He Kai Kei Aku Ringa 2023;
- 4 **noted** that the Ministers are proposing to measure success by upgrading existing Māori data in advance of developing a potentially enduring solution as part of the work on He Ara Waiora and Ngā Tohu Waiora;
- 5 **agreed** to the He Kai Kei Aku Ringa 2023 Action Plan attached as Appendix One to the paper under MCR-23-SUB-0018;
- 6 **noted** that the Ministers will publicly release the Action Plan as soon as practicable;
- 7 **authorised** the Minister for Māori Development and the Minister for Economic Development, in consultation with Māori Economic Development Ministers, to jointly approve minor and technical changes to the Action Plan; and
- 8 **invited** the Minister for Māori Development and the Minister for Economic Development to report back to MCR on progress in June 2024.
