Business Payment Practices Act Repeal Bill: Approval for Introduction

Portfolio Small Business and Manufacturing

On 29 February 2024, the Cabinet Legislation Committee:

- noted that a category 2 priority (must be passed in 2024) on the 2024 Legislation Programme is sought for the Business Payment Practices Act Repeal Bill (the Bill);
- **noted** that the Bill repeals the Business Payment Practices Act 2023 and revokes the Business Payment Practices Regulations 2023;
- approved the Business Payment Practices Act Repeal Bill [PCO 26085/2.5] for introduction, subject to the final approval of the Government caucuses and sufficient support in the House of Representatives;
- 4 **agreed** that the Bill be introduced as soon as practicable following Cabinet approval;
- 5 **agreed** that the Government propose that the Bill be:
 - 5.1 progressed through urgency;
 - 5.2 enacted by 26 May 2024.
