This document includes data requested by the external AEWV review team. Where relevant, additional comparisons and context is provided.

AEWV

Volumes: There have been 94,667 AEWVs approved between the category opening on 4 July 2022 and 11 November 2023.

Compared to previous equivalent visas (based on previously compiled data between July 2022 and 30 September 2023), there were over 89,000 AEWV approvals, compared to 71,100 people approved on Essential Skill and Work to Residence between July 2018 and September 2019.

Apart from higher volumes (that is likely to be somewhat associated with recent labour market conditions and a post border closure 'catch-up' period) most high-level trends in country of origin of applicant and occupations appear similar to previous known risk areas. INZ continue to monitor risk and outcomes, responding to more nuanced trends and insights as they become clear.

The system is 'circular' by design, and as INZ gathers further information about employers over time, malafide actors will be better detected and deterred by a suite of controls, including assessment practices, revocation, suspension and infringements which in turn will influence the applicant trends at the work visa gateway.

Occupation & Sector: The top 20 occupations approved on temporary work visas pre and post COVID-19 are similar. There are some changes, for example a larger number of builder's labourers and fewer waiters approved on AEWV. Construction, hospitality, primary industry, and health remain the top five sectors, with transport and logistics just edging out retail under AEWV (there were a higher number of bus drivers linked to the Green List announcement). There is a 10 per cent relative increase of visas for migrants in construction sector compared to pre COVID-19 (up from 25 per cent to 35 per cent of visas issued).

Skill Level: post COVID-19, 46 percent of AEWV holders are working in high to mid-skilled roles (ANZSCO skill level 1 – 3), compared to 62 percent of Essential Skill and Work to Residence visa holders pre COVID-19.

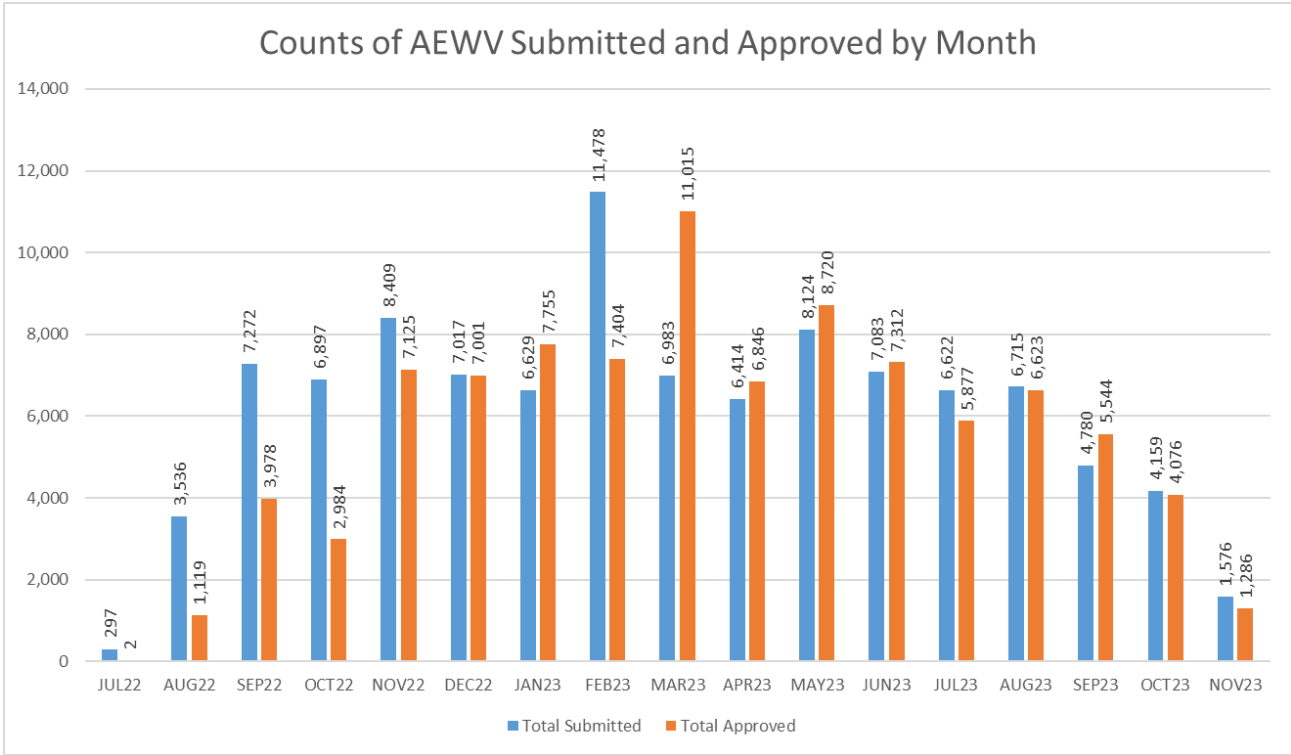
Wage: Despite sector agreement exceptions allowing lower rates, most AEWV holders are paid at or above median wage (over 80 per cent).

Nationality: Similar to the pre COVID-19 trend of temporary work visa holders, the top 3 nationalities of AEWV holders are India, Philippines and China.

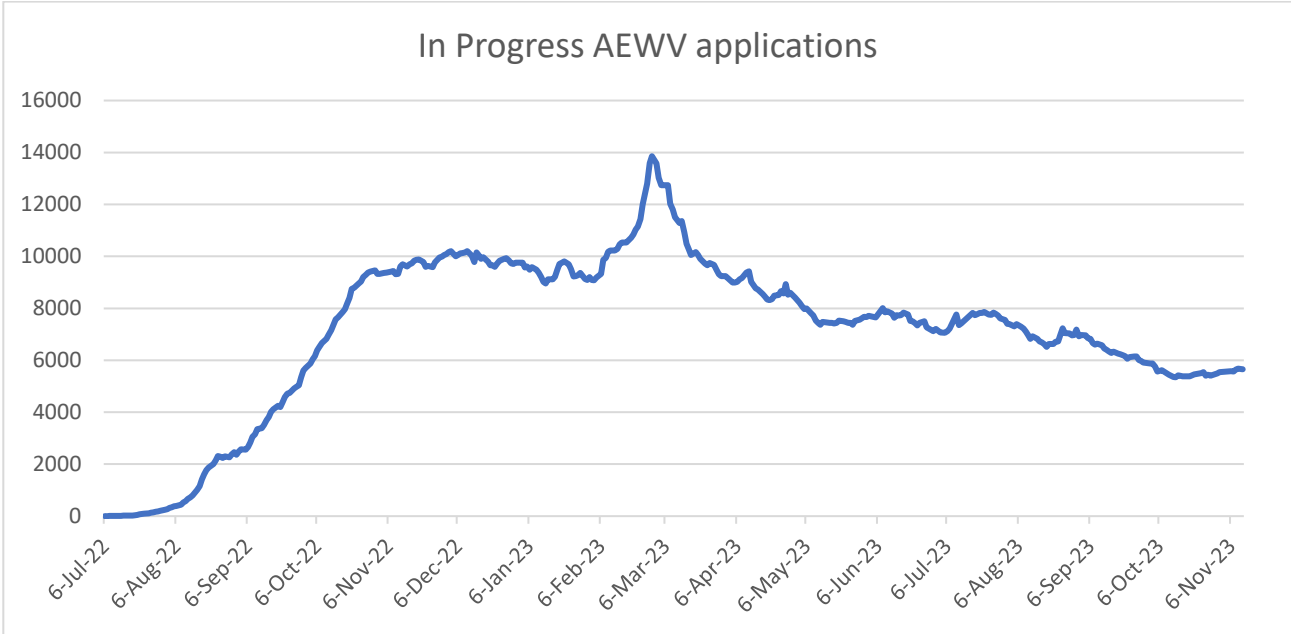

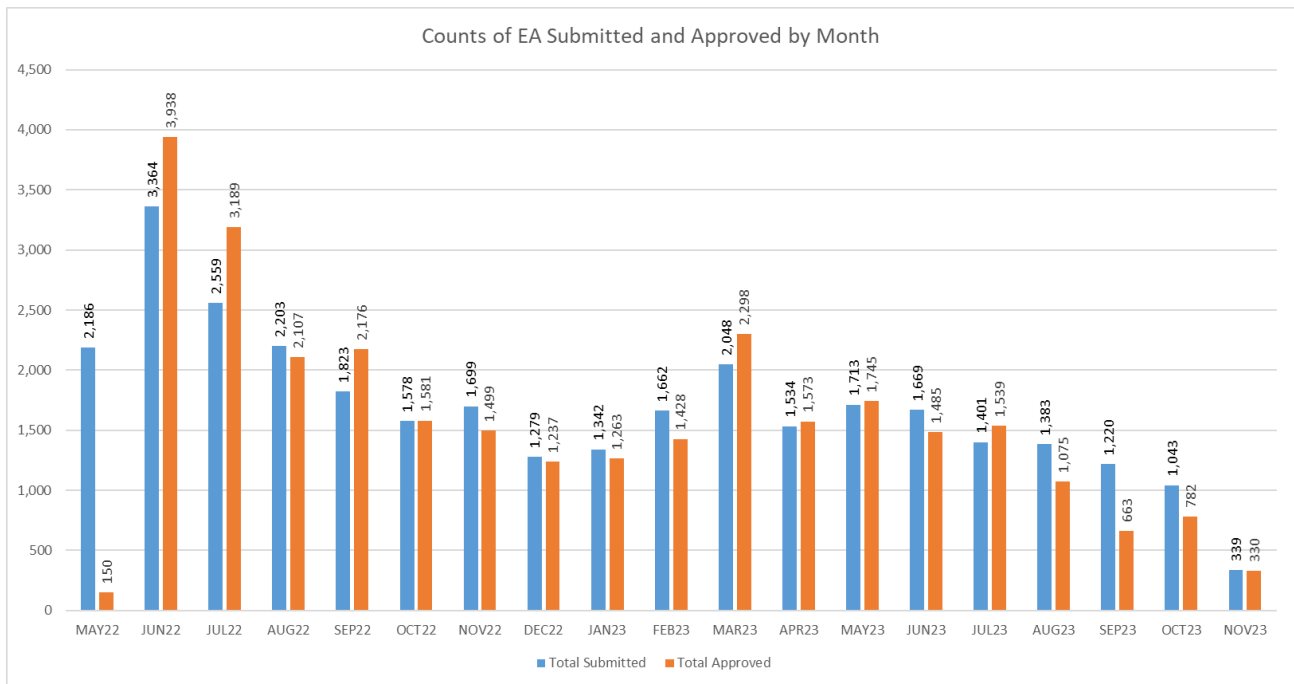

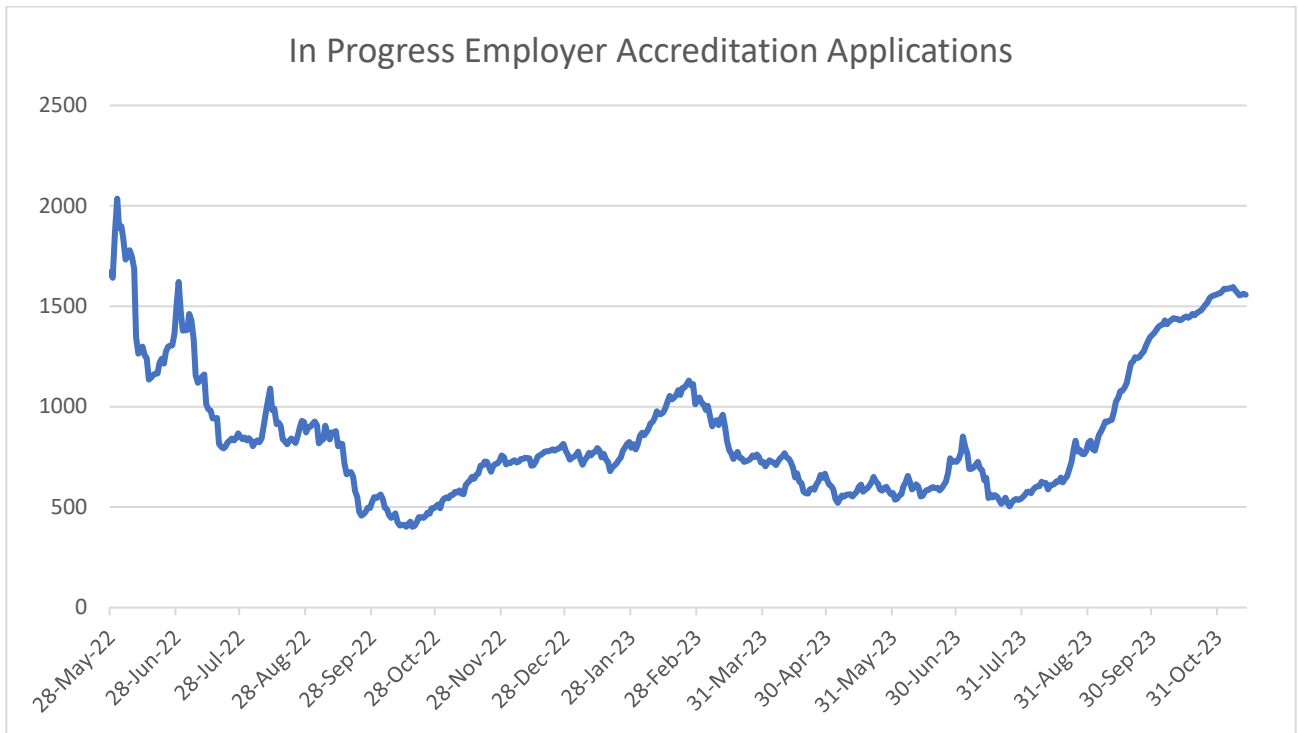

Employer accreditations in progress trend

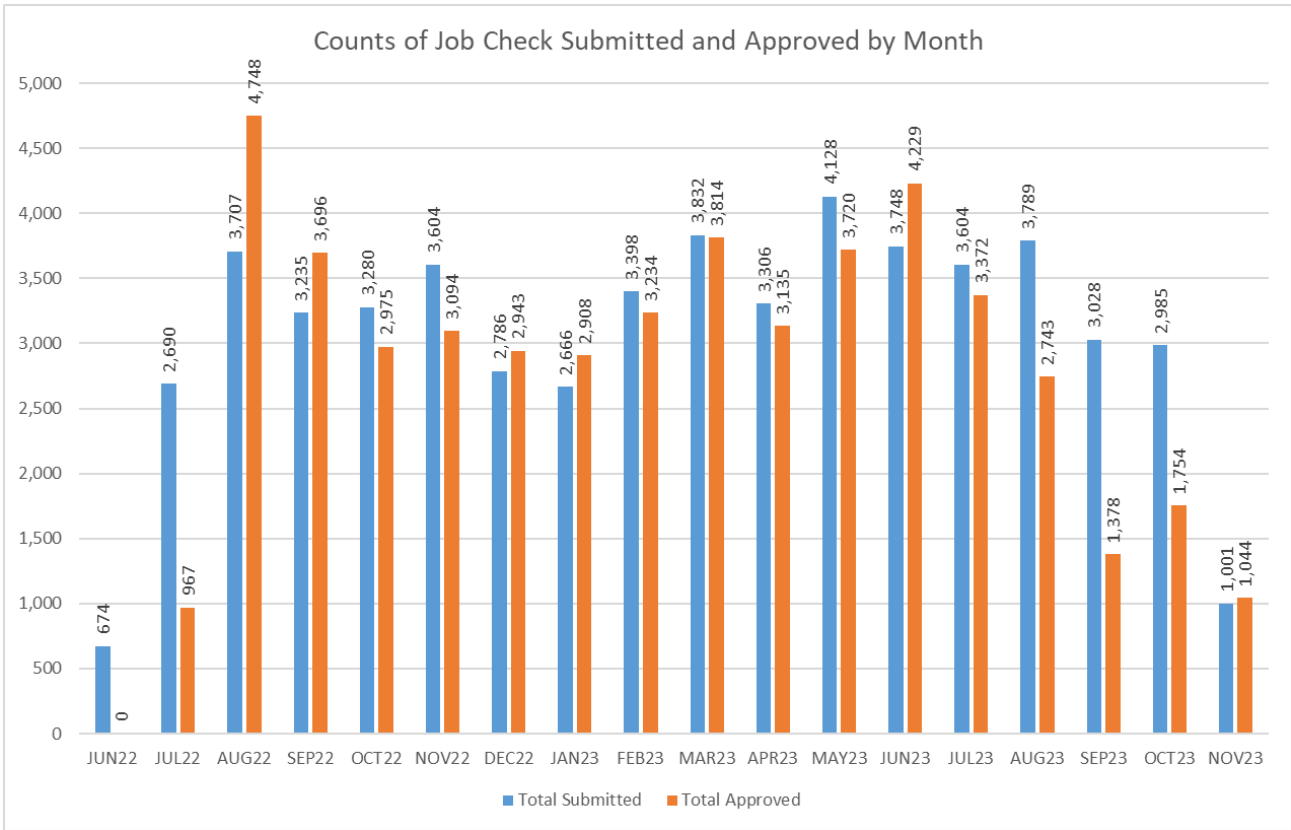

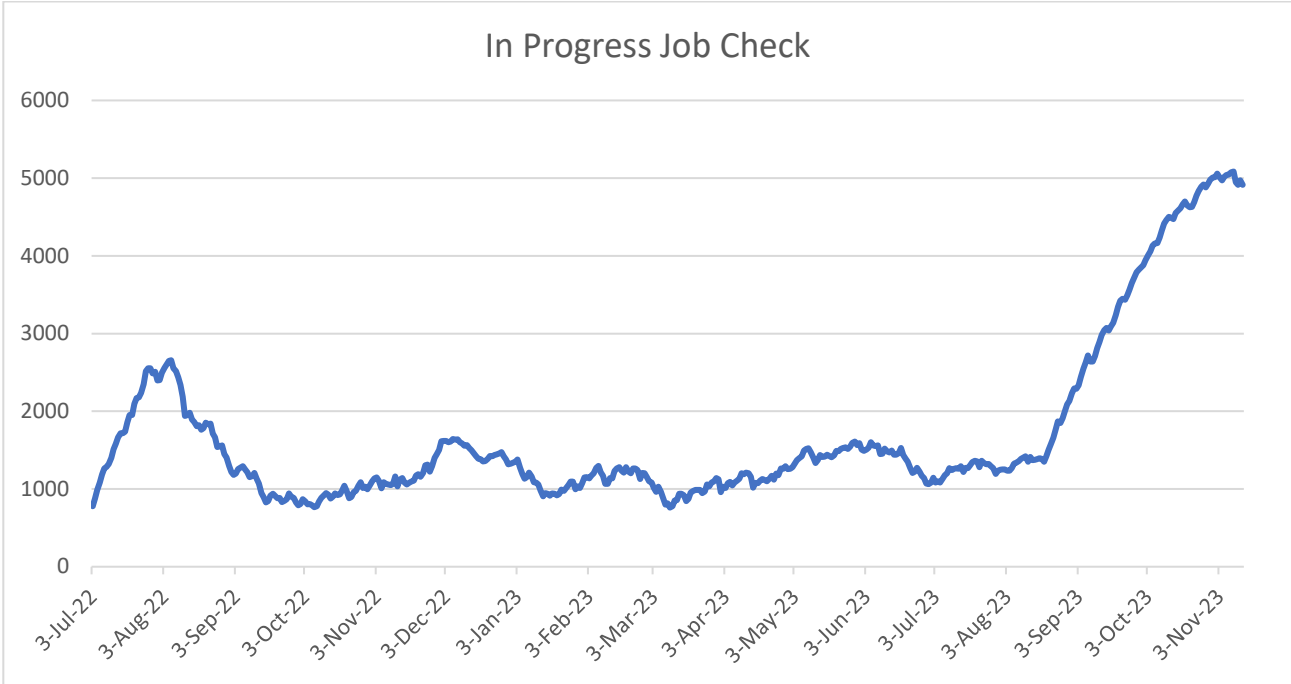

Job tokens

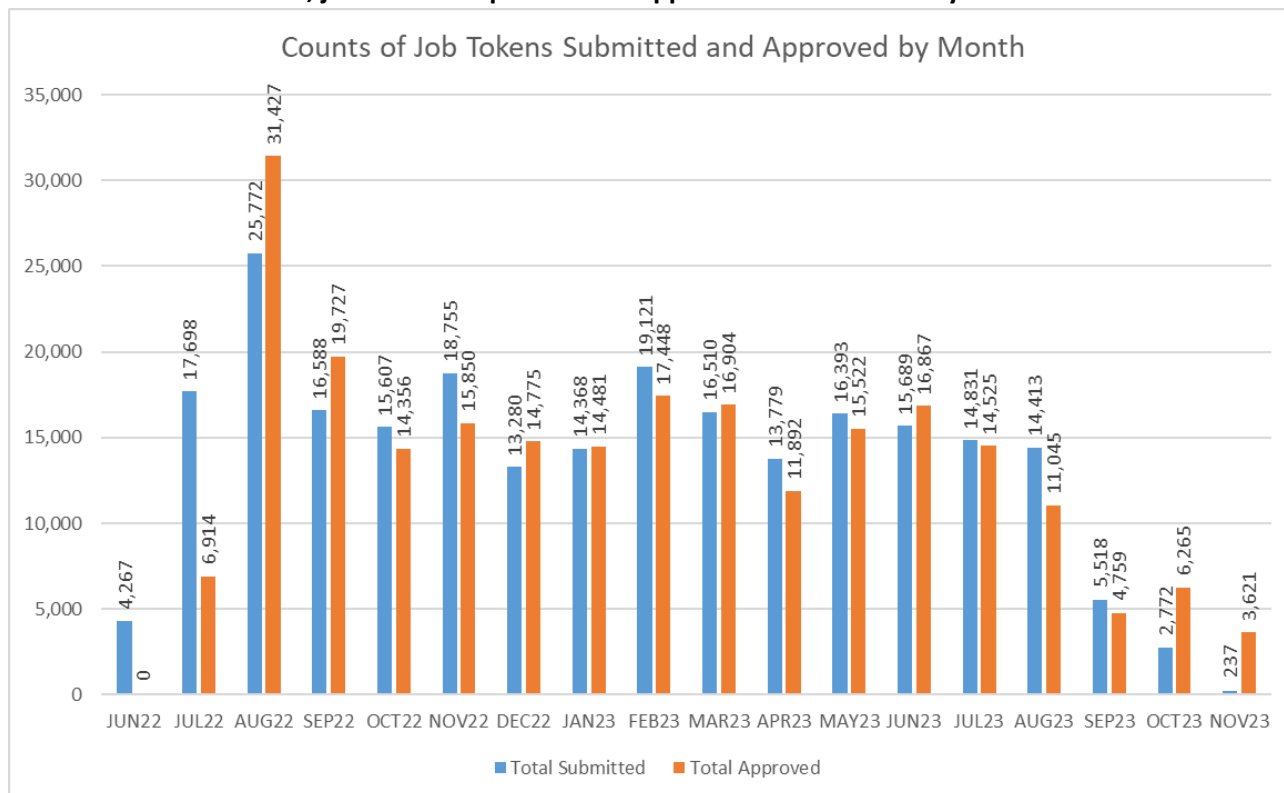
As of 11 November 2023, 49,754 job checks were approved for 236,378 roles.

There was a higher tolerance for accepting numbers of job vacancies prior to changes to the general instruction in August 2023. The general instruction changes included greater scrutiny on the numbers of job tokens, which appears to be having an impact on reducing the number of approved job tokens. Over time, we expect to see better information which reflects genuine vacancy trends. For now, roles approved through AEWV applications provide a more reliable indicator for understanding the actual demand from employers.

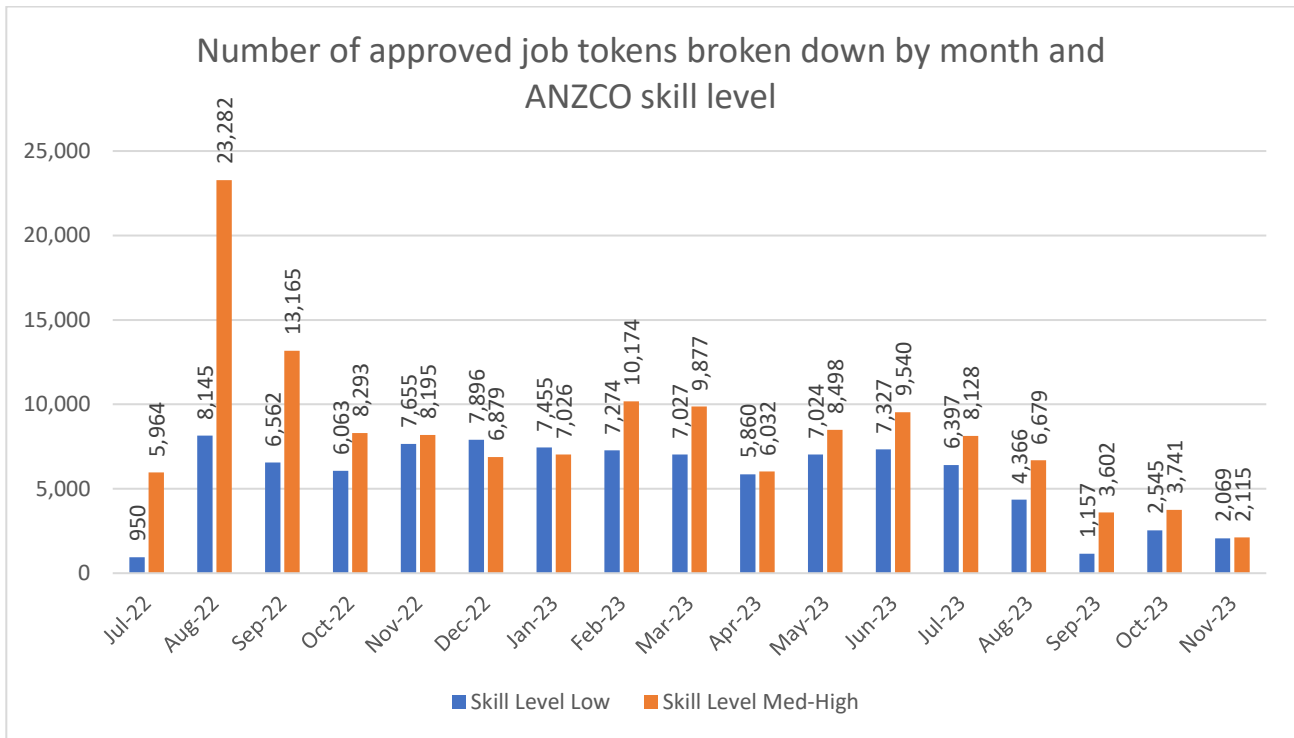

Each quarter, INZ forecasts the incoming volume of applications over the next three years across a variety of products. Each AEWV gateway is forecasted separately. INZ first forecasted the three AEWV gateways in January 2023 as data from 2022 could be used.

INZ use a statistical modelling technique to forecast incoming applications. These models accuracy is based on the quantity of historical data. Ideally, at least five years of historical volumes is needed for models to accurately predict yearly patterns and trends. AEWV is a new product with limited historical data. Therefore, INZ's forecasting models are considered less accurate compared to other products.

The forecasts rely on advice from subject-matter-experts (SMEs) within INZ to predict incoming application volumes for the three AEWV gateways. Each quarter, the predictions from the models are reconciled with the predictions provided by SMEs. As more data becomes available overtime, INZ expects our forecasting models to become more accurate which means there should be less reliance on SME advice for our predictions.

Below are key AEWV forecast assumptions:

- Historical volumes with outliers removed based on SME input.
- Renewal of accreditation or visa based on expiry dates.
- Assumed behaviour of employers (e.g., they will apply 3 months before expiry of accreditation and 90 percent of employers will decide to renew).
- Assumed visa holder behaviour (e.g., approximately 80 per cent will choose to reapply for an AEWV).
- Policy changes

Border entries and turn arounds

Over 65,700 AEWV holders have arrived onshore as at 28 October 2023. Since July 2022, there have been 18 AEWV on-holders who were refused entry, with the majority coming from Vietnam and India. This number does not include AEWV holders interdicted offshore.

The reason for turnarounds includes a near equal share of:

- Character concerns;
- lack of experience and training to fulfil intended job;
- lack of knowledge about role and what it entails; or
- employer in liquidation or offer of employment withdrawn.

Migrant Exploitation Protection Visa (MEPV)

As at 28 October 2023, 600 MEPV have been issued for previous AEWV holders, and 81 MEPV applications from AEWV holders were in progress.

Refugee (Asylum) Claims from AEWV holders to date

In the first quarter of 2023, 18 refugee and protection claims have been lodged from previous AEWV holders. These refugee and protection claims are yet to be decided. As of 3 November 2023, there are no AEWV holders who have had a refugee and protection claim approved. A breakdown of claims by entry visa is provided in the document attached for comparison.

These number include all employers and are not specific to accredited employers only. To specify whether the investigation was related to AEWV which required significant time and resource as it would require a manual search of each case.

These numbers are the totals of unique investigations cases, not the count of employers or the individuals involved. There may be duplicates in cases or multiple employers in one case.

The number of allegations received has increased in recent months and this is expected to continue. There are a range of factors that contribute to whether an allegation proceeds to an investigation including whether there is sufficient evidence to proceed.

Allegations of migrant exploitation have increased compared to historic volumes, and this has led to a greater proportion of active investigations related to employers than previous years. In addition to indicating higher levels of migrant exploitation occurring, it reflects the recent focus on providing information and education for migrants on how to report claims of exploitation, leading to more allegations. Whether exploitation has occurred must be determined through an investigation and therefore, until this has occurred, it is difficult to confirm the extent and nature of the harm. The temporary support package for MEPV holders has also likely increased volume of exploitation allegations in recent months.
