### Building (Dam Safety) Regulations 2022: Proposed Amendments

#### Portfolio Building and Construction

On 19 March 2024, the Cabinet Expenditure and Regulatory Review Committee:

- noted that in May 2022, the previous government approved the Building (Dam Safety) Regulations 2022 (the Regulations) [LEG-22-MIN-0052], which will come into force on 13 May 2024;
- 2 **noted** that the Regulations were intended to provide a minimum, consistent, and effective risk-based regulatory framework for post-construction dam safety while ensuring proportionate costs and regulatory burden;
- 3 **noted** that new modelling indicates that the current height and volume thresholds mean that a much larger number of dams will be subject to the Regulations, many of which will be dams with a low potential impact;
- 4 **agreed** that the height and volume threshold for a classifiable dam will be one that has a height of four or more metres and holds 20,000 or more cubic metres volume of water or other fluid;
- 5 **noted** that increasing the height and volume threshold may increase the likelihood that dams with medium or high potential impacts are not included in scope of the Regulations, and this risk can be managed under existing provisions in the Building Act 2004;
- 6 **authorised** the Minister for Building and Construction to issue drafting instructions to Parliamentary Counsel Office to give effect to the policy decisions in the paper under EXP-24-SUB-0007;
- 7 **authorised** the Minister for Building and Construction to make decisions consistent with the decisions under EXP-24-MIN-0007 on any issues which arise during the drafting process, including minor or technical amendments as required;

8 **noted** that officials intend to communicate the above decisions to key stakeholders affected by the Regulations, prior to the legislation commencing, to support these stakeholders to comply.
