Crown Minerals Act 1991: Change of Control of Operator Regulations

Portfolio Resources

On 2 May 2024, the Cabinet Legislation Committee:

- noted that in April 2021, the previous government agreed to make minor and technical amendments to regulations under the Crown Minerals Act 1991 to specify application requirements and the recovery of fees for change of control of Tier 1 operator applications [DEV-21-MIN-0059];
- **noted** that the four sets of amendment regulations attached to the submission under LEG-24-SUB-0064 will give effect to the decision referred to in paragraph 1 above;
- authorised the submission to the Executive Council of the:
 - 3.1 Crown Minerals (Petroleum Fees) Amendment Regulations 2024 [PCO 24135/3.0];
 - 3.2 Crown Minerals (Minerals Fees) Amendment Regulations 2024 [PCO 24136/3.0];
 - 3.3 Crown Minerals (Petroleum) Amendment Regulations 2024 [PCO 24137/3.0]; and
 - 3.4 Crown Minerals (Minerals other than Petroleum) Amendment Regulations 2024 [PCO 24138/3.0];
