# Enhancing Telecommunications Regulatory and Funding Frameworks: Release of Discussion Document

Portfolio Media and Communications

On 9 April 2024, the Cabinet Expenditure and Regulatory Review Committee:

- **noted** that while the telecommunications regulatory framework is generally delivering good outcomes for New Zealanders, the Minister for Media and Communications (the Minister) believes some enhancements should be actively explored, including:
  - 1.1 removing any unnecessary restrictions on some fibre providers (including those originally put in place at the start of the Ultra-Fast Broadband initiative) to support business growth and innovation and the potential development of more rural connectivity solutions;
  - 1.2 introducing greater flexibility to how the Telecommunications Development Levy is set, to allow the Government to respond to rural connectivity needs in a timely way whilst also managing cost-of-living impacts;
  - 1.3 updating some settings to account of market and technological change, such as the growth in low-earth orbit satellites in our market; and
  - 1.4 other potential changes to ensure the telecommunications regulatory regime remains fit for purpose;
- **approved** the release of the discussion document titled *Enhancing Telecommunications Regulatory and Funding Frameworks*, attached at Appendix One to the paper under EXP-24-SUB-0020, subject to any minor and technical changes that the Minister considers necessary;
- noted that the Minister intends to report back to Cabinet on the next steps and any proposed policy decisions on these matters following consultation.
