It's absolutely essential to bring our appalling housing stock up to code, and WKH has delivered this mahi relatively well. It does have to be more flexible though to address broader issues including repairs, weather tightness, mould, ventilation etc. to help the most impacted whānau. That also means going more strongly after landlords (I know this is addressed elsewhere but this can be a carrot if landlords of very vulnerable tenants get greater subsidies - as long as they get obliged to keep renting at the same rates to them for a certain period of time)

As I said, going after landlords, identifying the most vulnerable whānau and the worst housing - might mean partnering much more closely with community and frontline providers rather than doing it top-down via EECA.

This one is crucial and something we've been saying since the inception of WUNZ:HS that was missing in the insulation and clean heating subsidies. Often, there are a lot of repairs and weather tightness improvements needed before many Kiwi homes are even ready for insulation.

Super important, needs to have money and teeth behind it. We may need to start hearing about actual legal and serious financial consequences for slum landlords. What this doesn't address is the housing shortage and amount of fear a lot of vulnerable tenants have of their landlords. Again, I'd say partner with community orgs and local councils to tackle this problem from the ground up. Another issue I personally encountered is how lax the Healthy Housing Standard is. I sold my dilapidated, uninsulated, single-glazed, freezing and mouldy South Coast bach to the airport in 2020, and rented it for 2 years after. The first 12 months there was a moratorium as I was the previous owner. After that, they did not even do the minimum fixes (including a new window that was installed wrong, without flashing, and where water got into the bedroom when it rained), and yet I got a certificate that the house qualified under the Healthy Homes Standard! I cannot stress enough how unhealthy that house was - it was leaky, had black mould and was 8C indoors in winter until the (inadequate) heater was turned on, which we could fortunately afford. If that is how that standard is enforced, there is no way that underprivileged whānau will get help to live in the housing everyone deserves. We also have culturally an incredibly lax attitude to housing stock that the rest of the Western world would condemn as unliveable.

Lack of affordable and healthy housing full stop. We don't have enough, even wealthy Kiwis live in appalling conditions (I did, until recently!). With increased immigration we'll have even more of a housing crunch and our poorest whānau suffer the most. Also, overcrowding isn't addressed here and it must. E.g. we must build larger homes for Pasifika whānau who are used to communal living. Co-housing, papakāinga and eco-communities should be supported, both financially and by removing red tape.

Yes, and an online portal isn't enough. Plus, getting that information to be accurate according to different contexts requires more resource-intensive efforts such as face-to-face advice and home visits. Nothing beats those to get a real understanding of what whānau's barriers and needs are. The HEAT kits we upgraded under SEEC funding had 100% successful uptake of very vulnerable whānau undertaking 2 weeks of daily activities measuring their home and energy performance. That is a good way of doing some bottom-up education rather than just providing information. Lack of information is often not the problem - lack of understanding and empathy is.

Support kanohi ki te kanohi provision of information and targeted in-home support by trusted navigators instead of more expensive topdown information provision (EECA has done that for years and our energy literacy rates are still dismal). Also: never promise % or \$ savings without really understanding the lived experience, they are often meaningless and can actually make things worse.

I've done so much qualitative research here and in North America, with households and small businesses, and very few understand complex rate and plan offerings and tariffs, nor what their bill actually means. Should also be part of widespread energy literacy training, but the regulators should get involved as well to ensure pricing structures and billing is adequate and equitable.

One of the huge aspects missing in the "8 things that cause energy hardship" is psychographic insights into behaviours, cultures, household politics, values, attitudes, and the psychology around stigma, whakamā, judgement, status etc. I would desperately like to see some proper funding behind understanding that aspect of energy hardship better!

The global energy crisis is real and staggering in its impact. We are somewhat but not completely isolated and the trilemma of how to balance decarbonising the energy system, managing community and infrastructure resilience and adapting to a collapsing climate, and ensuring energy justice when the whole system is built on structural injustice, is hitting us just as hard here. A lot more collaboration, co-design and willingness to tackle big issues like decolonisation and mana motuhake are essential.
