# **International Visitor Conservation and Tourism Levy Review 2024**

### Portfolio Tourism and Hospitality

On 15 April 2024, the Cabinet Business Committee:

- 1 **noted** that there is an opportunity to explore how the costs of tourism could be more effectively priced into the visitor experience;
- **agreed** to a four-week consultation on the International Visitor Conservation and Tourism Levy (IVL) Rate Review, seeking feedback on four options of the amount for the IVL (either keeping the status quo of \$35, or an increase to \$50, \$70 or \$100), and IVL investment choices, including tourism, conservation, and potentially other sectors affected by tourism;
- **authorised** the Minister of Finance, Minister of Conservation, and Minister for Tourism and Hospitality to agree to the content and release of a discussion document for consultation, in line with the matters in the submission under CBC-24-SUB-0019;
- 4 **noted** that the Minister for Tourism and Hospitality will return to the Cabinet Economic Policy Committee to share any recommendations and outcomes by June 2024.
