# Proposed Overseas Travel: Hon Judith Collins KC – April 2024

- 1 I seek Cabinet approval to travel to the United States from 8 to 14 April to attend the 39<sup>th</sup> Space Symposium in Colorado Springs and undertake engagements in support of my Space, Science, Innovation and Technology, and Defence portfolio responsibilities.
- 2 This will be an 'Advanced Technology and Aerospace Mission', and I will be utilising my participation at the Symposium alongside New Zealand firms to accelerate our export and investment growth.
- 3 The Prime Minister has approved the travel in-principle, and House leave has been approved from the Party Whip.

# **Purpose of Travel**

- 4 The purpose of my attendance at the Space Symposium in Colorado Springs is to raise the profile of, and open opportunities for, New Zealand's space sector to an international audience.
- 5 The Space Symposium in Colorado Springs is a global event that provides business and networking opportunities across all sectors of the space ecosystem.
- 6 I have been invited to speak at the Symposium on Wednesday 10 April in the 'Space Leaders Spotlight – One on One Conversations'.
- 7 In 2023 the Symposium attracted over 10,000 people from more than 40 countries. In contrast to other export sectors, overseas government and private sector customers, as well as potential investors, expect to see the New Zealand government clearly standing behind our firms. The government also plays a critical role in opening doors for our researchers to collaborate with NASA and other leading space science organisations.
- 8 While at the Symposium I intend to meet with senior international representatives relevant to my Space, Science, Innovation and Technology, and Defence portfolio responsibilities.
- 9 While in the United States, I also propose to undertake a series of engagements with prominent New Zealand and US firms, investors and technology leaders in Denver and Los Angeles.

10 Building connections to those with influence over international investment decisions, experience with commercialising innovation, and an understanding of what is required to scale-up and operate at a global level, will be valuable as we seek to make these shifts in the New Zealand economy.

- 12 While in the United States I will be accompanied by officials from the Ministry of Business, Innovation and Employment, and supported by New Zealand Trade and Enterprise, New Zealand Defence Force, the Ministry of Defence and the Ministry of Foreign Affairs and Trade staff, whose costs will be met by departmental budgets.
