### Proposed Overseas Travel: Hon Andrew Bayly - June 2024

Portfolios Commerce and Consumer Affairs / Small Business and Manufacturing

On 20 May 2024, Cabinet:

- 1 **authorised** the absence of Hon Andrew Bayly from New Zealand, from 9 to 13 June 2024, to travel to Singapore to attend the Singapore-Australia scams and fraud delegation meetings, and other bilateral meetings;
- 2 **agreed** that he be accompanied by one member of staff;
- 3 **approved** the estimated expenditure of up to \$26,760 for the travel expenses of the ministerial party as a charge to Vote Internal Affairs (Members of the Executive Travel);
- 4 **noted** that he will also be accompanied by an official from the Ministry of Business, Innovation and Employment and the Chief Executive of the New Zealand Banking Association, who will meet their own costs;
- 5 **agreed** that in his absence Hon Chris Penk act as Minister of Commerce and Consumer Affairs, Minister for Small Business and Manufacturing and Minister of Statistics;
- 6 **noted** that the House is not sitting during his absence.
