Financial Markets Conduct (Asia Region Funds Passport) Amendment Regulations 2024

Portfolio Commerce and Consumer Affairs

On 23 May 2024, the Cabinet Legislation Committee:

- 1 noted that in April 2016, the then government agreed that New Zealand should join the Asia Region Funds Passport initiative, and authorised the Financial Markets Authority to enter into the *Memorandum of Cooperation on the Establishment and Implementation of the Asia Region Funds Passport* (the Memorandum of Cooperation) on behalf of the New Zealand Government [EGI-16-MIN-0080];
- 2 **noted** that member countries, including New Zealand, have agreed to minor changes to the Memorandum of Cooperation to amend the process for making changes to the Memorandum of Cooperation and to also make other minor tidy-ups;
- 3 **noted** that the Financial Markets Conduct (Asia Region Funds Passport) Amendment Regulations 2024 (the Amendment Regulations) give effect to the changes referred to in paragraph 2 above;
- 4 **authorised** the submission to the Executive Council of the Amendment Regulations [PCO 26006/5.0];
- 5 **noted** that the Amendment Regulations will come into force on 30 June 2024.
