Review of Seismic Risk Management in Existing Buildings: Terms of Reference

Portfolio **Building and Construction**

On 29 May 2024, the Cabinet Economic Policy Committee (ECO):

- 1 **noted** that in March 2024, ECO agreed in principle to conduct a review of the management of seismic risk to existing buildings (the Review), and invited the Minister for Building and Construction to report back by 31 May 2024 with the proposed Terms of Reference for the Review [ECO-24-MIN-0043];
- 2 **agreed** to the objectives, scope and process for the Review, as set out in the proposed Terms of Reference attached to the paper under ECO-24-SUB-0087;
- 3 **agreed** that the Review be led by the Ministry of Business Innovation and Employment, with an independent Chair to be appointed, and the Review supported by the procurement of technical and other expert input as appropriate;
- 4 **authorised** the Minister for Building and Construction to make decisions consistent with the Government's overall objectives relating to the paper under ECO-24-SUB-0087, on any issues that arise during the Review process, including minor, technical and timing changes as required.
