Coordination of Government Initiatives and Engagement in Auckland

Portfolios **Local Government / Transport / Auckland**

On 19 June 2024, the Cabinet Economic Policy Committee (ECO):

- 1 **noted** that the Minister for Auckland has an advocacy and coordination role, providing oversight and ensuring a whole-of-government approach is taken to matters affecting Auckland;
- 2 **noted** that the Minister for Auckland maintains a relationship with the Mayor of Auckland, Auckland Council's Governing Body and Auckland Council Controlled Organisations on behalf of the Government;
- 3 **noted** that awareness of Ministerial engagements with the Mayor of Auckland, Auckland Council's Governing Body and with the board and executive leadership of Auckland Council Controlled Organisations will assist the Minister for Auckland to maintain a productive working relationship with Auckland local government on behalf of the Government;
- 4 **noted** that the CabGuide will be updated to include a new section reminding Ministers and agencies of expectations regarding consultation with the Minister for Auckland on matters requiring Cabinet approval that will have a significant or disproportionate impact for Auckland;
- 5 **noted** that officials from the Ministry of Business, Innovation and Employment, working through the Auckland Policy Office, will coordinate consultation with the Minister for Auckland on matters requiring Cabinet approval that will have a significant or disproportionate impact for Auckland;
- 6 **invited** the Minister for Auckland to provide a report back to the ECO six-monthly on the cross-government work programme in Auckland;
- 7 **agreed** that the Minister of Transport progresses work reviewing governance, accountability arrangements, and roles and responsibilities for transport planning in Auckland including where responsibility for the Auckland Regional Land Transport Plan sits;
- 8 **invited** the Minister of Transport to report back to ECO in August 2024 on progress made on the work described in paragraph 7 above.
