To inform you of the process to close the MBIE Pacific Economic Development programmes and seek your approval on the communications plan, and related documents, including letters in your name.

# Background

- 1. After your consideration of previous fiscal information (briefing 2324-1498 refers) you directed officials to close three of the Pacific economic development programmes by the end of the 23/24 financial year. To close the programmes, we will terminate existing contracts from this date.
- 2. This briefing outlines the process for the closure of three Pacific economic programmes managed by MBIE:
  - a. Auckland Pacific Skills Shift (Alo Vaka)
  - b. Pacific Business Procurement Support Service (PPSS)
  - c. Senior Diverse Leaders Capability Pilot (Tū Mau Mana Moana).
- 3. It seeks your agreement on the communications plan and relevant documents including letters in your name to key stakeholders for each programme, including those appointed to programme related governance and leadership groups.

# **Programme Closure: Communications Plan**

4. To inform our stakeholders of the Government's decision to close the MBIE Pacific economic development programmes, we have developed a communications plan (Annex One). The plan outlines a structured approach to manage stakeholder communication effectively, ensuring that the programme closure is handled with professionalism and cultural sensitivity, and to deliver a clear and concise message about the discontinuation of the programme.

### Stakeholders

- 5. The Pacific economic programmes have a range of stakeholders that need to be informed of the programme closure. This includes partner organisations and governance groups comprised of officials:
  - a. Alo Vaka:
    - The three delivery partner organisations: Tātaki Auckland Unlimited, The Southern Initiative and The Cause Collective.
    - The evaluators for the Alo Vaka programme: Sapere.
    - Alo Vaka Governance Group.
    - Alo Vaka Oversight/Working Groups.
  - b. Pacific Procurement Support Service:
    - Our delivery partner: Pacific Business Trust.
    - PPSS Governance Group.
- 6. Due to their role in the programmes it would be appropriate that these stakeholders receive a letter from you informing them of the Government's decision to close the programmes. We have included draft letters for delivery partner organisations in Annex Two. Officials will work with your office to send these to stakeholders. Governance Groups will be informed of programmes' closure by officials.

- Tū Mau Mana Moana Working Group.
- 7. Both Leadership NZ and Deloitte will have completed their contract milestone delivery by 30 June 2024 so will not need a letter to communicate the termination of their contracts.

**Commercial Information** 

### Timing

- 11. We understand that you will take an oral item to Cabinet on closure timing relating to Just Transitions and Pacific economic development programmes, and you will receive talking points for Cabinet that cover off both. Contract terminations can be timed for after any budget day announcement reflecting the budget-sensitive nature of this action or as soon as possible prior to this date.
- 12. It is important that MBIE notifies stakeholders as soon as practical. Contracted stakeholders are currently making business decisions based on future funding provided under these contracts. This will mitigate future commercial risk.
- 13. The focus will be on ensuring key stakeholders are informed at a similar time.
- 14. Officials will also travel to Auckland to discuss with key delivery partners.

## **Current contracts**

15. The current contracts with our delivery partners for these programmes end between 29 March 2024 to 30 June 2025:

- 16. Upon your direction we will work with contracted parties to terminate programme contracts with our delivery partners by 30 June 2024. The contracted evaluator will complete a final report by 30 September 2024.
- 17. Legal professional privilege
- 18. We will provide you with further advice on the termination of each contract, including any final amounts owing on each contract.

# **Next Steps**

- 19. Upon your agreement to the communications plan, we will engage with your office and subsequently enact the plan to inform stakeholders and begin the process to terminate selected contracts by 30 June 2024.
- 20. We recommend that you forward this briefing to the Hon Dr Shane Reti, who has an interest in these programmes as the Minister for Pacific Peoples. We would work together with the Ministry for Pacific peoples to align with any broader Government messaging in relation to Pacific work.
