Comment

The Multi Year Appropriation (MYA) is from 1 February 2022 to 30 June 2024 and it had a total budget of \$46.15 million. Total spend to 30 June 2023 was \$23.7 million leaving \$20.075 million for 2023/24. For the financial year 2023/24 there was spend of \$15.9 million leaving an underspend of \$4.172 million to be transferred to Major Events MYA at October Baseline Update as approved by Cabinet.
