Additions to the List of Occupational Diseases: Approval to Consult

Portfolio ACC

On 23 October 2024, the Cabinet Social Outcomes Committee:

- noted that in September 2022, the previous government agreed to the framework for reviewing the list of occupational diseases in Schedule 2 of the Accident Compensation Act 2001 (Schedule 2) [SWC-22-MIN-0388];
- 2 **noted** that:
 - 2.1 in January 2023, the former Minister for ACC informed the House of Representatives that a review of Schedule 2 would occur;
 - 2.2 the current Minister for ACC (the Minister) has agreed to continue this review;
- **approved** public consultation on all fourteen of the independent panel of health expert's recommended additions to Schedule 2;
- 4 **approved** the release of the discussion document *Seeking feedback on the proposed* additions to *Schedule 2 of the Accident Compensation Act 2001* (the discussion document), attached to the submission under SOU-24-SUB-0126;
- noted that the Minister is required under section 336(2) of the Accident Compensation Act 2001 to only make recommendations to amend Schedule 2 after consulting the persons or organisations that he considers appropriate, and that by undertaking this public consultation the Minister is fulfilling these requirements;
- **authorised** the Minister for ACC to make minor amendments to the discussion document before release if required;
- noted that, following public consultation and receiving final policy advice from the Ministry of Business, Innovation and Employment and ACC, the Minister intends to seek final policy decisions from Cabinet on the amendments to Schedule 2.
