Amendments to the Electricity (Safety) Regulations to Expand the Permitted Voltage Range for Electricity Supply: Approval to Consult

Portfolio Energy

On 23 October 2024, the Cabinet Economic Policy Committee (ECO):

- **noted** that amending the permitted voltage range for electricity supply on low voltage electricity networks could defer or reduce network investment and support solar Photovoltaic uptake;
- 2 **noted** that the proposed increase in the regulated upper supply voltage limit is considered low risk, would be consistent with existing standards for appliances, and would align closer with Australia;
- noted that the discussion document attached under ECO-24-SUB-0241 proposes increasing the regulated upper supply voltage limit from +6 to +10 per cent above nominal voltage;
- 4 **approved** the release of the discussion document for a consultation period of up to six weeks;
- authorised the Minister for Energy to approve minor technical and editorial changes to the discussion document prior to publication;
- **noted** that the Minister for Energy intends to report back to ECO with final proposals following consultation.
