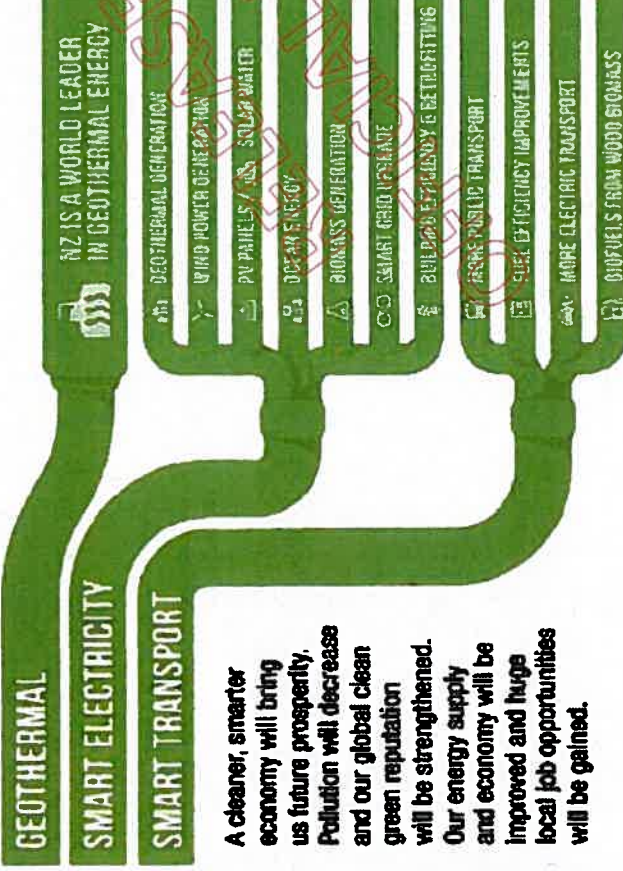

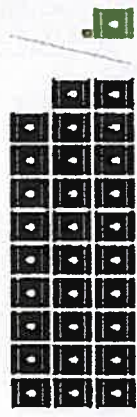

Te Reinga Basin Anti Deep Sea Oil Drilling Hikoï from Cape Te Reinga to Waitangi

A hikoï calling for national support to protect the 4th largest Marine area in the world will leave Cape Te Reinga on the 1st of February and travel to Waitangi and arrive before the 6th of February to protest against deep sea oil drilling in Te Reinga Basin. A foreign Oil Drilling vessel owned by Statoil will arrive from Norway to drill into the Te Reinga Basin seabed at depths over more than 2000 metres looking for oil.

Despite unanimous resolutions at numerous hui by many hapu and iwi all around Tai Tokerau to fully oppose all deep sea oil exploration have been conducted last year, but has fallen on deaf government ears.

In April, 2004 over 40,000 Māori and supporters marched to Wellington in the Takutaimoana Hikoï led by Hone Harawira to oppose the infamous Foreshore and Seabed legislation. The Bill was a New Zealand government knee-jerk reaction to a court order that recognised Māori rights to the foreshore and seabed. Māori suspected that the government was planning to allow foreign investment into the seabed to explore for minerals and oil.

10 years after the Takutaimoana Hikoi, those suspicions have proven to be correct.

It is now evident to many New Zealanders that the Foreshore and Seabed Act 2004 and the Marine and Coastal Area Act 2011 were always about allowing foreign invasion of mining companies into our waters.

In recognition of continual denials by the government to recognise Māori mana motuhake and the rights of New Zealand citizens we call on nationwide support to oppose the laws that ignore Māori rights under Te Tiriti o Waitangi and ignore the rights of New Zealanders in light of referendums that ask for better consideration of our environmental concerns.

Discussions are also being held across the country with anti oil drilling activist groups to descend upon Waitangi Day celebrations in their local regions, to ensure that the John Key led Government understands that iwi environmental issues, are now a national kiwi issue.
