

2. Regional Updates

2.1 Hawke's Bay

PipeDrive update

As of 10 April 2019, 106 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 24 are awaiting assessment
- 23 are being assessed
- 2 are awaiting further information
- 13 are on hold
- 21 have been approved
- 23 have been unsuccessful declined, withdrawn or are unsupported.

Regional Activity

On 3 April, Provincial Development Unit (PDU) officials met with the Chief Executives of the five Hawke's Bay councils (Napier City Council, Hastings District Council, Wairoa District Council, Central Hawke's Bay District Council, and Hawke's Bay Regional Council) to discuss council-related applications. The Investment Director for the region outlined the focus areas for the Provincial Growth Fund (PGF) and discussed the upcoming package announcement.

A meeting was held with Wairoa District Council's economic development team to discuss intentions for redeveloping Marine Parade. This includes a number of initiatives aimed at drawing more people into the CBD, promoting building maintenance and growing retail activity. An application for PGF support for part of this plan is being prepared.

PDU officials met with Privacy of natural persons in Hastings to discuss a number of projects to encourage development of the industry. Developing skills capability is a particular focus for the industry, across all skill levels. PDU officials are supporting Com to identify where PGF support could be forthcoming. Com have been invited to give the Independent Advisory Panel (IAP) a high level overview of their strategy when they visit Hawke's Bay on 15 and 16 May.

Cross-agency support from Ministry of Social Development (MSD), Ministry for Primary Industries (MPI) and PDU is being offered to Ngāti Pāhauwera Development Ltd who has applied for funding under Whenua Māori to support an initiative in Wairoa.

Opportunities for Regional Digital Hubs in Hawke's Bay are being progressed.

Follow up support has been provided to the Hastings District Council (HDC)-led Hawke's Bay Food Innovation Hub development plan. The project team has submitted an application for the implementation phase.

2.2 West Coast

PipeDrive update

As of 10 April 2019, 77 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 3 are awaiting assessment
- 1 is being assessed
- 1 is awaiting further information
- 10 are on hold
- 18 have been approved
- 44 have been unsuccessful declined, withdrawn or are unsupported

Regional Activity

PDU Officials are currently finalising the remaining five contracts from the West Coast package.

An update on the other West Coast package contracts:

- Kawatiri Coastal Trail opened their project management office in Westport in mid-March and will receive responses to their design tenders by 12 April 2019.
- The Dolomite Point project management team is progressing their planning.

The feasibility study for the upgrade of the Westport and Greymouth ports is now complete and there is a meeting to discuss the study with the councils scheduled for 16 April.

The Principal Regional Advisor (PRA) met with Minister O'Connor and advised him of current PGF pipeline opportunities that officials are working on in the region.

There is ongoing work to support the team putting together the Pounamu Pathways project for a PGF application. The project team are currently putting together costs for presentation to the Regional Leaders at a meeting on 8 May. A funding proposal will be drafted after this meeting.

PDU West Coast officials are working with Te Puni Kōkiri (TPK) on five potential applications, including a possible Te Ara Mahi application.

Development West Coast is working on an application for three Regional Digital Hubs for the region.

PDU officials are working with applicants that have submissions that are 'On Hold' to either finalise their applications, or if they are unable to complete the application, requesting that they withdraw them.

2.3 Tai Tokerau/ Northland

PipeDrive update

As of 10 April 2019, 186 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 28 are awaiting assessment
- 15 are being assessed
- 10 are awaiting further information
- 7 are on hold
- 49 have been approved
- 77 have been unsuccessful declined, withdrawn or are unsupported

Regional Activity

On 5 April, Minister Shane Jones and Deputy Prime Minister Winston Peters announced \$21 million of PGF projects at Waiparera Marae in Panguru. These projects are:

- Kaipara and Mid-north water storage of \$18.5 million to unlock land for horticulture use.
- Three marae in Hokianga will receive PGF funding for digital connectivity, with the first two marae in Kaitaia and Dargaville already connected.
- The first Regional Digital Fub is planned to open in Kaitaia and June McCabe on behalf of Taitokerau Fibre Network (TFN) has submitted an application to the PGF for this.
- A \$3.2 million project to rebuild the Opononi seawall and improve the resilience of State Highway 12.

Crown Forestry have agreed on two joint ventures – one with Te Uri o Hau land owners, the second with land owners based in Tapuwae forest. The total value of Crown investment over the life of these two projects is \$39 million over an area of about 3,800 hectares of forest.

The IAP are convening in Northland on 11 and 12 April. They will be in the midnorth (Kaikohe, Kerikeri and Waitangi) on 11 April, and on 12 April they will travel south to Whangarei (Marsden Point) where they will review a series of presentations from various local and national business interests.

Dr David Wilson has been the CEO of Northland Inc. for the past five years and has decided to return home to Auckland Privacy of natural persons

Vaughan Cooper has been appointed as the interim CEO, while a recruitment process for Dr Wilson's replacement is undertaken.

Upcoming Announcements

Minister Jones and Deputy Prime Minister Peters will announce an investment in a heavy machinery training centre on 12 April 2019. The announcement is based on investing in training and upskilling locals from Whangarei in the use of heavy machinery, which will address potential skills shortages in this area.

3. Other Updates

3.1 Digital dashboard

Digital update for the month of March

After last month's spike in traffic, the number of users visiting the website has dropped 10% as traffic has stabilised to more regular levels. This drop in users also results in a corresponding drop in related metrics such as number of sessions, average time on site, and unique page views.



While the overall number of sessions dropped, traffic arriving to the site through Twitter and LinkedIn increased significantly by 122% and 400% respectively on the previous month.

Despite the decrease in overall traffic, the number of users accessing the list of 'All Announced Projects' status spreadsheet has increased, which suggests a steady interest in this information.



Branded searches (i.e. queries related to 'Provincial Growth Fund' or 'Grow Regions') continues to be the major source of search engine traffic to the website. The Te Ara Mahi and He Poutama Rangatahi projects are also in the top ten search queries bringing traffic to the website.
