Insolvency Practitioners Bill: Supplementary Order Paper

Portfolio Commerce and Consumer Affairs

On 30 April 2019, the Cabinet Legislation Committee:

- 1 **noted** that the Insolvency Practitioners Bill (the Bill)
 - 1.1 holds a category 3 priority (to be passed if possible in 2019) on the 2019 Legislation Programme;
 - 1.2 is currently awaiting its committee of the whole House stage;
- 2 **noted** that on 3 April 2019, the Cabinet Economic Development Committee agreed to insert a provision in the Bill by way of Supplementary Order Paper to enable the Registrar of Companies to charge a levy to companies (and other entities that can be liquidated) for the provision of independent oversight of the Insolvency Practitioners regime [DEV-19-MIN-0065];
- 3 **approved** the release of the Supplementary Order Paper to the Insolvency Practitioners Bill [POO 14143-4/1.8], which gives effect to the decision in paragraph 2;

agreed that the Supplementary Order Paper be released by 18 June 2019.
