2. Key Updates

2.1 Māori Business Leaders Awards

Māori Business Leaders Awards

On 10 May 2019, Provincial Development Unit (PDU) representatives attended the Māori Business Leaders Awards at Old Government House in Auckland. Now in their 15th year, the awards celebrated Māori success in the business sector.

2.2 Wairoa – Napier Line Update

Wairoa – Napier Line Update

The Wairoa to Napier Railway investment includes funding for three projects: the Wairoa to Napier railway construction (\$5 million), the variation for storm damage (\$1.2 million), and the Tairāwhiti Railway Tourism Feasibility Study (\$225,000). This upgrade will see the rail line operating at a safe standard for low speed (50kph) forestry transport operations. Indications of volume commitments from forestry owners will account for approximately 80% of the available weekly capacity.

Progress is tracking well and the line is on target to open in June 2019. The inaugural meeting of the project steering group for the Tairāwhiti Railway

Feasibility Study, including KiwiRail representatives, will occur on 12 June 2019 in Gisborne. The feasibility study will be developed by Business and Economic Research Limited (BERL) and branches.

In addition, mitigating due diligence issues stalled progress. We are continuing to facilitate the delivery of a study which accurately assesses the costs and opportunities related to the rail line between Wairoa and Napier.

2.3 Palmerston North Logistics Hub Update

Palmerston North Logistics Hub Update

The Palmerston North Regional Freight Hub project is well underway, with iwi and other stakeholder engagement being undertaken. The focus over the coming months is on the design phase, which will occur in conjunction with the multi-criteria analysis to identify potential sites.

The \$40 million Provincial Growth Fund investment covers the cost of design, designation and land acquisition. KiwiRail has indicated they expect any consequential investment will occur in the construction phase, which is three to five years away.

3.1 Waikato

PipeDrive update

Regional Activity

PDU officials hosted Under-Secretary Fletcher Tabuteau for a regional visit in the Turangi/Taupō area on 14 and 15 May. The visit included meetings with the Taupō Mayor, David Trewavas, and Great Lake Enterprise Taupō for an overview on the key regional development issues and challenges facing the district. Commercial Information

The second day of the visit included meetings with Ruapehu Alpine Lifts, Hillary Outdoors Education Centre, the National Trout Centre and Otūkou marae.

The business case for the Sugarloaf wharf expansion is now complete, ^{Commercial Inform}
The business case has estimated a total cost of \$ ^{Commercial} million to upgrade the facility. There are ^{Commercial Inform} still to be worked through.

The business case for the Coromandel Marine Gateway has been completed ^{Commercia}

Feasibility studies for the Te Aroha Tourism precinct and the Wāharoa Industrial Hub are progressing well, with project management and governance now in place.

Te Waka: Waikato Regional Economic Development Agency

Te Waka were successful in receiving capacity funding which will be used to recruit a Programme Manager and Project Support person to accelerate successful PGF applications for the region.

Māori Economic Development

The re-launch of the Waikato Region Māori Economic Action Plan has been postponed until June, due to the availability of Minister Mahuta. Waahi Pa submitted an application for digital connectivity and will progress through this over the next few months.

Ahikoomako (Centre for Māori Innovation and Entrepreneurship) will be launched by Te Wananga o Aotearoa on 31 May. This project is being supported by the PDU.

3.2 Manawatū - Whanganui

PipeDrive update

As of 15 May 2019, 83 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 33 have been unsuccessful - declined, withdrawn or are unsupported.

Regional Activity

Whakapapa Gondola project ('Sky Waka')

Development of the new Whakapapa Gondola is progressing well, though the programme is tracking approximately one month behind timelines set in October 2018. Planning is underway to ensure that remaining works have the least impact on visitors once winter operations commence on 1 June 2019. Minister Jones will be attending the official opening of the Sky Waka in August.

Ruapehu District Destination Plan

Hui with Iwi have been progressing over the past month and the response has been positive.

Accelerate25 (A25): Horizons Regional Economic Action plan

The governance group for the A25 Programme meets on 17 May 2019. This group includes representatives from regional council, district council, Iwi, and the Senior Regional Official (SRO) for the region. PDU officials will attend to provide an update on current investments, to inform the A25 plan refresh that is being scoped.

Accelerate 25: Primary Sector Reference Group

The A25 Primary Sector Reference Group is reviewing their strategic objectives as part of the refresh of the Regional Economic Action Plan.

The Rural Innovation Lab held a series of successful workshops across the region over recent weeks. Ministry for Primary Industries (MPI) officials will be attending their governance group hui on 28 May 2019.

The Tararua District Council is running workshops to present their phase one alternative land use findings, which is a PGF funded project.

Whanganui and Partners are meeting with landowners at Hiruharama to progress an action plan for the area as a spiritual tourist attraction based on the religious order and work of Mother Aubert.

Skills and Employment

Skills and employment are a major focus for the Manawatū-Whanganui region. This is being led by the A25 Skills and Employment sub-group. A series of working groups for each district has been established in order to ensure that the group's focus reflects the needs of each community. PDU officials are engaging with these groups to ensure they are aware of the funding opportunities available and so that an early view of potential applications can be obtained.

Work is progressing on the Skills and Employment Hub for Manawatū. This will be based in Feilding and will leverage off the site at the National Driving Training Centre. A governance group has been formed with the first official meeting due in the next two weeks. An opening date has been set for 1 July 2019.

Consultation continues on the development of Regional Investment Plans for Employment. The challenge is to develop a plan that is inclusive of the diverse and geographically-spread labour markets in the region. The next meeting is on 17 May 2019 in Whanganui and a meeting will be held in Ruapehu in the coming weeks.

Māori Economic Development

On 16 April 2019, officials held a One Billion Trees (1BT) informative event at Kingsgate Hotel in Whanganui targeted at Māori landowners. There was strong attendance with approximately 30 participants. The purpose of the event was to provide an overview of the 1BT programme, including the funding options available, with detail around each funding stream and to engage individual landowners in technical discussion on their pending applications where appropriate.

On 1 May 2019, MPI officials supported the Iwi Assets and Māori Land Entities Symposium held in Ōtaki.

3.3 West Coast

PipeDrive update

As of 15 May 2019, 79 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 5 await assessment
- 1 is being assessed
- None await further information
- 6 are on hold
- 19 have been approved
- 48 have been unsuccessful - declined, withdrawn or are unsupported.

Regional Activity

PDU officials are finalising the remaining four contracts from the West Coast package.

Of the other contracts from this package, both the Kawatiri Coastal Trail and Dolomite Point projects are in the planning stage. PDU officials will attend monthly governance meetings for these projects.

PDU officials attended a meeting with the Mayors and Chief Executives of Buller District Council and Grey District Council on 16 April 2019 to discuss recommendations outlined in the PGF-funded joint feasibility study into the operation of the West Coast ports. These recommendations resulted in the need to commission a further report to answer key questions on governance and structure; the right size of the ports' assets for the future and resilience and maritime safety requirements. **Commercial Information**

PDU and Department of Conservation (DOC) officials met with the Commercial Informa on 24 April 2019 to give an update on the PGF approach to the West Coast and discuss projects the group is considering. The group has a strong tourism focus.

PDU officials attended the Lighthouse Group meeting on 30 April 2019. This group comprises all six of the West Coast's tourism promotional groups. The consultants conducting the Hokitika to Westport KiwiRail feasibility study were one of the

keynote speakers presenting to the Group to gain stakeholder feedback on the project.

The team that is putting together a PGF application for the Pounamu Pathways project delivered a presentation to the Regional Leaders, Mayors and Chairs meeting on 8 May. In principle, the Regional Leaders support the project and agreed to further work being needed before the draft application can be completed.

PDU and Te Puni Kōkiri (TPK) officials are working with several applicants on potential Whenua Māori projects. Additionally, PDU officials are investigating potential Te Ara Mahi (TAM) projects in the region.

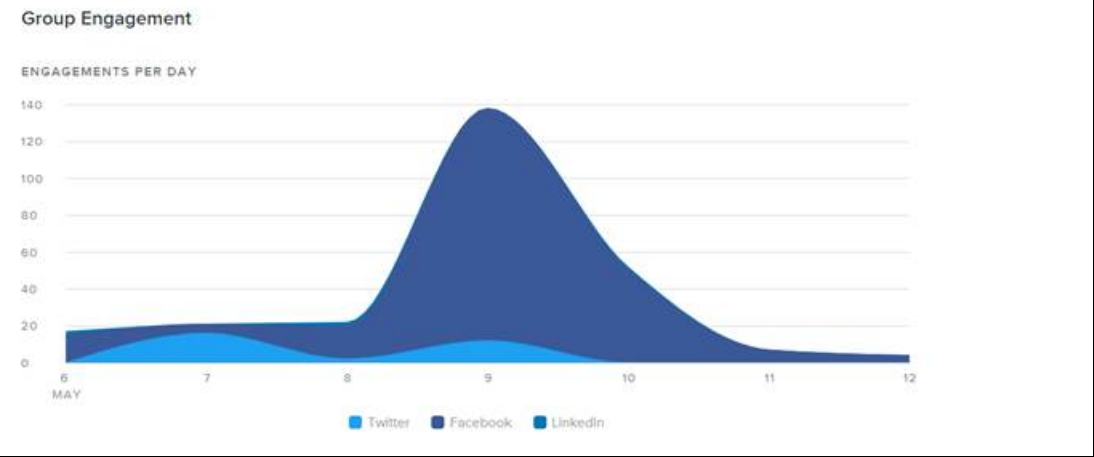
