Major Events Management (Olympic Games and Commonwealth Games Emblems and Words) Order 2019

Portfolio Economic Development

On 20 August 2019, the Cabinet Legislation Committee:

- 1 **agreed** that the Schedule of the Major Events Management Act 2007 be amended:
 - 1.1 to reflect upcoming Olympic Games and Commonwealth Games events;
 - 1.2 remove emblems and words associated with past Olympic Games and Commonwealth Games events to protect, control and prevent unauthorised use of those emblems and words relating to those events;
- 2 **noted** the proposed amendments are routine in nature and do not require any new policy decisions, and that the Treasury has agreed a Regulatory Impact Statement is not required;
- 3 **noted** that the attached Major Events Management (Olympic Games and Commonwealth Games Emblems and Words) Order 2019 will give effect to the decision referred to in paragraph 1 above;
- 4 **authorised** submission to the Executive Council of the Major Events Management (Olympic Games and Commonwealth Games Emblems and Words) Order 2019 [PCO 22201/2.0];
- 5 **noted** that the Major Events Management (Olympic Games and Commonwealth Games Emblems and Words) Order 2019 comes into force on 1 October 2019.
