Draft Minerals and Petroleum Resource Strategy: Release for Public Consultation

Portfolio Energy and Resources

On 21 August 2019, the Cabinet Economic Development Committee (DEV):

- 1 **noted** that the draft Strategy document *Responsibly Delivering Value: A Minerals and Petroleum Resource Strategy for Aotearoa New Zealand: 2019-2029* (the draft Strategy), attached to the paper under DEV-19-SUB-0220:
 - 1.1 sets out the government's long-term vision for the minerals and petroleum sector;
 - 1.2 will underpin the Tranche Two review of the Crown Minerals Act 1991, and guide future government policy affecting the sector;
- 2 **agreed** to the release of the draft Strategy document for public consultation, subject to any minor or editorial changes that may be required;
- 3 **noted** that the consultation period is intended to commence from 27 August 2019 and conclude on 20 September 2019;
- 4 **invited** the Minister of Energy and Resources to report back to DEV for approval of the final Strategy **Negotiations**
