在新西兰，你必须持有正确的签证种类才可以在性行业里工作。

谁可以在新西兰做一名性工作者？

新西兰公民	可以。你还可以经营或投资一个商业性的性服务生意。
学生签证持有者 工作签证持有者 访客签证持有者	不可以。从事商业性的性服务违反了你的签证条件，你可能会被遣返。如果你有什么疑问，请致电 0508 558 855向新西兰移民局咨询。
新西兰居民	你可以在新西兰做一名性工作者，但是如果你经营或投资商业性的性服务生意，你可能被遣返。

# Sex work in New Zealand

It is important to check you hold the correct visa before working in the sex industry in New Zealand.

## Who can be a sex worker in New Zealand?

<b>New Zealand citizen</b>	Yes. You can also operate or invest in a commercial sex business.
<b>Student visa holder</b> <b>Work visa holder</b> <b>Visitor visa holder</b>	No. Performing commercial sexual services is a breach of your visa conditions and you can become liable for deportation. Please contact Immigration New Zealand on 0508 558 855 if you have questions.
<b>New Zealand resident</b>	You can be a sex worker in New Zealand. You cannot invest in, be a director of, own or manage a commercial sex business.

É importante verificar se você possui o visto correto antes de trabalhar na indústria do sexo na Nova Zelândia.

## Quem pode ser um(a) trabalhador(a) sexual na Nova Zelândia?

<b>Cidadão da Nova Zelândia</b>	Sim. Você também pode operar ou investir em uma atividade comercial de sexo.
<b>Titular de visto de estudante</b> <b>Titular de visto de trabalho</b> <b>Titular de visto de visitante</b>	Não. A prestação comercial de serviços sexuais é uma violação das condições do seu visto e você pode estar sujeito(a) à deportação. Em caso de dúvidas, comunique-se com a Imigração da Nova Zelândia pelo telefone 0508 558 855.
<b>New Zealand resident</b>	Residente da Nova Zelândia Você pode ser um(a) profissional do sexo na Nova Zelândia, mas pode estar sujeito(a) à deportação se operar ou investir em uma atividade comercial de sexo.

<b>ผู้ถือวีซ่านักเรียนนักศึกษา (Student visa)</b> <b>ผู้ถือวีซ่าทำงาน (Work visa)</b> <b>ผู้ถือวีซ่านักท่องเที่ยว (Visitor visa)</b>	ทำไม่ได้ การประกอบการค้าบริการทางเพศเป็นการฝ่าฝืนเงื่อนไขวีซ่าของตนเอง และท่านอาจถูกเนรเทศออกนอกประเทศ หากท่านมีข้อสงสัยใดๆ กรุณาติดต่อสำนักงานตรวจคนเข้าเมือง ที่หมายเลข 0508 558 855
<b>ผู้พำนักอาศัยในนิวซีแลนด์ (New Zealand resident)</b>	ท่านสามารถทำงานค้าบริการทางเพศในนิวซีแลนด์ได้ แต่ท่านอาจถูกเนรเทศออกนอกประเทศหากท่านดำเนินการหรือลงทุนในธุรกิจค้าบริการทางเพศ
