The bill's objective No 1 and 2 provides for a very low bar. The key to any 'offer' is that it should not be client capture or entrapment and that decisions are informed. The specific conditions of the offer needs to be fully outlined.

2. If the exception allowing financial advice providers to use unsolicited meetings to make offers is retained, should there be further restrictions placed upon it? If so, what should they be?

The restrictions/standards should be the same for all financial advice providers. This is especially so since the categories have been removed and where the adviser is offering a conflicted product.
